A penalty shall be assessed if Dog License is not secured on or before January 31, or within 30 days after the dog becomes 3 months of age, or is brought from outside the state.

Neatly correct your address, telephone number, or any information concerning your dog. If you have acquired a new dog add it to the application. If you no longer have a dog listed on the application please let us know so your account will not show as being delinquent. **You must be 18 years of age to purchase a dog license. If you received an application and are not of age, someone over 18 will have to register the dog.**

**Licenses may be purchased at the Auditor's office or the Animal Shelter during regular business hours.**

**The fee for 2006 Dog License is \$10.00 per dog. After the January 31, deadline, the fee is \$20.00 per dog. All Kennel License must be purchased at the Auditor's Office, the Dog Pound, or New Bedford Country Store, New Bedford, Ohio.**

### **PURCHASE BY MAIL**

You may return the enclosed application to us, along with the proper fee, and we will mail your tag (s) back to you. All envelopes must be post marked by January 31, to avoid the late penalty. **Please make all checks payable to: Sandra K. Corder, Coshocton County Auditor and mail to 349 Main Street, Coshocton, Ohio 43812.** Enclose a self-addressed, stamped envelope and the price of license. All items will be returned with your license. If you live in the city limits you are required to send a copy of your rabies vaccination certificate in with the application. Dogs living outside of the Coshocton city limits are no longer required to include proof of rabies vaccination.
