SPECIFICATIONS FOR SUPPLYING CULVERT PIPE COSHOCOTON COUNTY ENGINEER

GENERAL SPECIFICATIONS

The Coshocoton County Commissioners, 401½ Main Street, Coshocoton, Ohio 43812 are requesting bids for Corrugated Polyethylene Smooth Lined pipe for use by the County Engineer's Office. The pipe shall have soil tight, integral, gasketed couplers.

All culvert pipes must conform to the pertinent sections of the State of Ohio Department of Transportation Specification 707 as listed in the current Construction and Material Specifications.

Unit prices shall include delivery to the Coshocoton County Engineer's Garage, 23194 County Road 621, Coshocoton, Ohio 43812.

The Bidder shall provide the following information with their proposal:

- 1) Manufacturer of each size of pipe quoted; and,
- 2) Certification that quoted pipe meets ODOT Specification.

A copy of the invoice shall be provided to the County at the time of delivery. Delivery shall be scheduled Monday through Friday, from 7:30 A.M. to 1:00 P.M. All materials shall be delivered by Friday, **April 1, 2011** unless agreed to otherwise by the County Engineer.

The single award will be based upon the cumulative total of the unit prices multiplied by the quantities on the bid sheet for sizes 12" through 60".

Each proposal must be accompanied by a certified check or a bid bond in an amount equal to five (5%) percent of total bid tendered and made payable to Coshocoton County Commissioners. The check of successful bidder will be returned within 30 days of the completion of the delivery of the culvert pipe to the Coshocoton County Engineer.

The County Commissioners reserve the right to reject any or all bids, or waive any irregularities.

NOTICE TO BIDDERS

Coshocton County Commissioners, 401½ Main Street, Coshocton, Oh. 43812, will accept sealed bids for culvert pipe to be used by the County Engineer. Bids will be accepted until **9:00 a.m., Wednesday, February 9, 2011** at which time they will be opened and read publicly. Each proposal must be accompanied by a certified check or a bid bond in an amount equal to five (5%) percent of total bid tendered, and made payable to Coshocton County Commissioners as a guarantee that, if the proposal is accepted, a purchase agreement will be entered into in accordance therewith. The check of successful bidder will be returned within 30 days of the completion of the delivery of the culvert pipe to the Coshocton County Engineer.
