Resolution 2007-383

Mr. Fischer made a motion, seconded by Mr. Stahl to rescind Resolution 2007-383 declaring it necessary to levy a tax in excess of the ten mill limitation for a 2 mill additional levy for the operation, maintenance and/or construction of buildings or acquisition of property for a Coshocton County Emergency Medical Service for a period of 5 years.

Resolution 2007-384

Mr. Stahl made a motion, seconded by Mr. Fischer to rescind Resolution 2007-384 declaring it necessary to levy a tax in excess of the ten mill limitation for a 1 mill additional levy for the support of county criminal justice services under section 307.45 of the ORC., which may include the following: Operation, maintenance, and/or construction of building or acquisition of property for a Coshocton County Justice Center/Correctional Facility for a continuing period.

This board has not lost focus or direction of that.

Resolution 2007-385

Mr. Fischer made a motion, seconded by Mr. Stahl to sign Resolution 2007-385 to request Auditor certification for a 2 mill replacement with decrease levy for the operation and maintenance of the Coshocton County Emergency Medical Services for the citizens of Coshocton County. This is a replacement with decrease for a period of 5 years.




