Investment Portfolio

Received the Monthly Investment Portfolio for the months of February and March 2008 from Ms. Michelle Darner, Coshocton County Treasurer. She then mentioned CDARS which is a certificate of deposit. Ohio Heritage Bank is now offering these certificates. The beauty of this type of CD is that the money stays locally and she has invested \$500,000 of the county's monies. The interest rate on this maturity is higher than the other maturities around the area. Real Estate settlement is going out soon and collection was down slightly. She doesn't have all the statistics at this point, but will inform the Commissioners of the exact totals when she has them. The Commissioners thanked her for attending.

EMS Update - Mr. Bernie Minet

Mr. Bernie Minet attended the meeting to update the Commissioners on the EMS coming back under the county. Mr. Minet stated that Mr. Perkins had provided a timeline and he is still following that same timeline. All employee applications have been turned in and they will continue this process. Once he determines who will qualify, he will turn over a list of employees to the Commissioners. He has begun the process of going over all current contracts and changing them from LLC to Coshocton County. Ms. Beck explained the county's process for getting contracts signed and what is expected of the EMS. He stated that they plan to have a temporary budget in place in June and then a full year budget by the end of this year. He is working with Mr. LaVigne to get the EMS on line. They hope to have this up and running by the end of this month. There may be some bugs to work-out, but he feels things will go smoothly. Our biggest issue is the bidding of the EMS billing. He stated that he is working with Ms. Beck to make certain we get everything taken care of for this process. He then stated that Ms. Cosmar is working to create a call list. This will be of the calls received and how they were handled. Mr. Shryock stated that the Commissioners intend to start the hiring process for the EMS Directors position. They plan to discuss whether or not to advertise, hire within the organization or in general, determine how they will go about hiring for this position. Mr. Minet stated that he feels that they are ahead of the timeline that was put in place. The Commissioners thanked him for attending.
