Commissioners discussed installment loan options for 2 trucks. Mr. Shryock has asked Mr. Batchelor for an opinion as to whether or not the Commissioners could borrow the money from a bank. Quotes for a plow truck for the Maintenance Dept. were over \$25,000 with the state purchase price of \$22,000. The Dog Warden truck quote was \$22,000 with the state purchase price of \$16,500. No action was taken.

Commissioners discussed the 5-15-08 letter from County Engineer, Fred Wachtel concerning ESRI and a proposal by them for unlimited licenses for various GIS projects. They would like Fred to be scheduled on the agenda to come in and talk about this subject. They would also like to see the other offices that would benefit from this to be present. No action taken.

Jeff Wherley-Litter/Recycling

Mr. Wherley gave an update on the Litter program. Mr. Wherley gave the Commissioners a copy of his budget and expenses so far this year . Half of his budget is gone for dumping litter at the landfill. He has spoken to Skip's Refuse who will have an 8 yard container at their location for \$110.00 a month. This will come out money ahead if he can use this option. Mr. Wherley will be coming back to ask for more money before the end of the year mainly because of the tire disposal fees. Mr. Wherley will also ask the Solid Waste District for more money when the time comes. The Commissioners are fine with Mr. Wherley contacting Skip's.

Mr. Wherley wanted the Commissioners to know that Mr. John Fielden caught a lady dumping trash on the road by the Hydrological Station. John had taken pictures of her tramping down the hill. She's going to court.

Mr. Shryock was contacted by Dick Erman, Canal Lewisville Church concerning a cleanup day. Mr. Wherley will get with Dick to furnish trash bags and vests.

Tim Greer - Maintenance Update

Mr. Greer gave an update on maintenance issues. The Public Defender's improvements will be started in June. Colors picked for siding is pebble stone clay and green for the metal roof. The Commissioners also discussed an ice guard which saves on the gutters. This should be done while they are working on the roof.

Tyler McKee will be leaving end of Aug/Sept. Need a replacement for him. Last time an internal notice was sent out for the replacement position JFS helped. Make a note to pursue.

Letter to Sheriff - Justice Center

Commissioners agreed to draft a letter to the Sheriff asking for a recommendation for potential site location of the new Justice Center and also for levy committee members. Time is growing short to make these decisions.
