Departmental Budget Meeting

Mrs. Robin Schonauer, Mrs. Ann Hartsock, Mrs. Janet Mosier, Mr. Steve Champaign, Mr. Doug Schonauer, Mrs. Teresa Bradford, Mrs. Sara Jane Lindsey, Mrs. Marissa Mullet, Mrs. Debbie Bowman, Mr. Jeff Mullen, Lt. Mr. Fischer opened the meeting and thanked everyone for attending. He stated that budgetary issues are on everyone's mind. State and Federal budgets are continually changing. He deferred to Mr. Shryock. Mr. Shryock stated that we have worked the last couple days on the numbers. Next year, we will probably not attempt to set a budget by the first of the year. He personally will take full responsibility for setting the first budgets. The numbers used are not good numbers for this year. He went over the funds and we are not going to have near the monies as we first thought. He stated that we are looking at the federal government to help us with this situation. He stated that he feels we should spend those monies that are given to us and we should appropriate as much as possible. He also feels we should protect the county as well. With that being said the state has cut 4.5% and have come back and cut an additional 7%. They have said in the next budget to anticipate a reduction of 25%. He then distributed a handout to all in attendance. He stated that there is a lot of input on this budget from the Treasures Office and the Auditor's Office. He stated that last year the county actually collected \$9,508,406.00, with a \$819,998.00 carryover for a total of \$10,328,404.00. We appropriated for 2009 \$9,841,252.00, which left a carryover for 2010 of \$487,152.00. When we received the 2009 amended certificate, the available revenue was \$8,666,766.00, and adding in the carryover, \$819,998.00 bringing the total available for appropriating to \$9,486,964.00. We feel it necessary to keep a cushion of \$246,000.00, the monies required to keep the county going for gas, electric, ect., is \$1,744,239.00. The mandated funds requested by the courts are \$1,463,573.00 this leaves \$6,032,952.00 to appropriate over the remaining funds. If we go by 2008 appropriations, we are short \$656,135.00. This is roughly a 10% across the board cut for the remaining funds. Mr. Shryock stated that we are anticipating a cut to the Local Government Funds, real estate property tax, investment income and some other miscellaneous funding may possibly be decreased because we are waiting on an Attorney Generals Opinion to determine if we are able to contract the dispatching for the EMS. Mr. Shryock stated that we were trying to set a budget on actual 2008 expenditures and not estimates for 2009. He then stated that we will go back to waiting until we have actual numbers to set the budgets in the future. The sales tax, other than two months of the year was up last year, ending the year with an increase of approximately 4% overall. Mr. Fischer stated that we hope everyone understands that when the budget was set previously we gave priority to mandated departments. He stated that we wanted the departments to hear this directly from them and not the newspaper. He stated that everyone will be hit with the cuts this time. We still have decisions to be made, we are looking at several options and it could be anywhere from 8-10 percent. Mr. Lee stated that we will be as fair as possible in the cuts and it could be as Mr. Fischer said anywhere from 8-10%. Mr. Shryock stated that in hind sight we possibly should have looked at estimated numbers instead of actual revenue, but he will accept full responsibility. Mrs. Corder stated that she spoke with the state office and they are stating that the sales tax is down 10% on the state level. We don't know our numbers at this time. She stated that they are saying we can anticipate a 5% decrease in our sales tax this year. Mr. Fischer stated that we are all going to have to be a little leaner in 2009. It is difficult to make these decisions when you know you will be affecting people's lives. Mr. Wachtel stated that at this time we are working on 50% of what we thought we were getting. Mr. Shryock stated that all non-general fund budgets were set at 100%. However, those are only temporary appropriations at this time and will be finalized when we set the 2009 budgets. The Commissioners thanked everyone for attending.
