Discussion-Fresno

Mr. Brent Haynes attended the meeting to discuss the Fresno project. He asked what the plans for traffic flow will be when they are working on the waste water lines. He also is concerned about the storm water drainage system that was put in place during the 1930's. He stated that he did talk with the architect and explained that they should go behind the houses and not down CR 172. Mr. Shryock stated that during the preconstruction meeting this issue was discussed and traffic is to be addressed as well as the street should be re-paved. He also stated that the Commissioners are not engineers and he would like to have GGC Engineer's give Mr. Haines a call to discuss his questions. They thanked him for attending and expressing his concerns.

Discussion - Mike LaVigne - City/County IT Partnership

Mr. Mike LaVigne, Mrs. Robin Schonauer, and Ms. Tiffany Swigert attended the meeting to discuss a possible partnership between the City and the County for IT services. Mr. LaVigne stated that he spoke with the Mayor last Friday and the City would like to move forward with a City/County Partnership. He was not specific, but Mr. LaVigne feels they may want the County to take over their network. There will need to be an agreement and he would like to connect their fire, maintenance, water and sewer. Mr. LaVigne told them that they will be responsible for paying for the hook-up of any and all of the buildings they want networked. It still needs to be determined what exactly we are going to supply and then we will need to determine a cost for this. Mr. Fischer asked if we have the capability of taking this on. Mr. LaVigne stated that he hasn't looked at all the buildings, so he can't really determine if we can do this or not at this time. Mr. LaVigne asked if this is something we want to burden the county with. Mr. Shryock stated that his concern is whether this will burden the IT Department. He does not want any county agency to not be able to get help if they need it because our IT department is working on the city. Mr. Fischer stated that if he understands Mr. LaVigne, the network will not have an issue taking on the City; however, the staff may possibly be overloaded. Mr. LaVigne stated that we won't know that until we determine exactly what the City is asking of the County. Mr. Shryock stated that we need to talk with the City to determine exactly what they need and how to proceed. Mr. LaVigne stated that he will meet with the city next week to go through their buildings. Once he does this, he will get back with the Commissioners.

Mr. LaVigne then stated that he had AT&T go back over and reconfigure our connections and through negotiations we can save an approximate \$1,057.00 per month. We will need to sign another 5 year contract. He was also able to negotiate a charge to hook fiber to Hopewell. The cost will be approximately \$600 per month. The Commissioners thanked him for attending.
