## **ODNR** Grant

Mr. Jeff Wherley attended the meeting to discuss the request for Ohio Department of Natural Resources (ODNR). Mr. Wherley stated that he has the opportunity to apply for funding through ODNR for Litter Collection as well as Residential Recycling. He would like to apply for \$10,000 for the Litter Collection and \$23,000 for the Residential Recycling. He will likely utilize the Litter Collection monies to cover the cost of fuel and he would like to utilize the monies for Residential Recycling to get one or possibly two new recycling trailers. He is requesting permission to pursue this grant funding. The Commissioners are very much in favor of him applying for this grant funding.

### Connect Ohio

Mr. Mike LaVigne and Mr. Jon Mosier attended the meeting to discuss Connect Ohio. Mr. Mosier stated that they attended a Connect Ohio meeting and they requested that the Commissioners go through Connect Ohio when requesting Stimulus Funding. They would like for the county to have a request in to them by the end of this month. They would like to do one grant request combined. There will be no charge to the county for having Connect Ohio make the request for funds. Mr. Fischer stated that as a point of clarification, we should talk with One Community as well as Congressman Zach Space's Office before we commit to Connect Ohio. The Commissioners feel that we should support Connect Ohio's request for funding for a Community Center in Coshocton County and utilize possibly Zach Space's Office and One Community to request additional infrastructure funding. They will consider all their options and make a final decision at a later date.
