## City/County Park District

Mrs. Lori Everhart, Mrs. Alice Hoover and Mrs. Anne Miller attended the meeting to discuss the county waterline easement as well as a possible Levy. Mrs. Miller stated that the park has done everything they can do to cut expenses. She presented the Commissioners with a list of cuts they have made. Mr. Lee asked if they have any idea about the renewal of the golf course lease. Mrs. Everhart stated that they are discussing that with Golf Young at this time. Mrs. Miller stated that they would like to discuss the possibility of putting a levy on the November ballot to keep the park from closing. Mr. Shryock asked if they have a millage number. Mrs. Miller stated that if they

have approximately \$300,000 to get them through in the winter that should work. So, they would be requesting .4 to .5 mills. Mr. Fischer asked if this levy would be exclusive for Lake Park or would it also include the other parks in the county. Mrs. Miller stated that they felt that it will possibly be just for Lake Park. Mrs. Everhart stated that they feel that they need the full .4 or .5 mills to run their facility. Mr. Lee stated that the discretionary funds may be decreased if they were able to pass this levy and that would free up some monies for other parks. Mrs. Everhart stated that Fire Districts also get discretionary funding and they have levies as well. Mr. Shryock asked what a normal budget for them is. Mrs. Everhart stated that it has been as high as 1.2 million and most recently down to around \$600,000. The Commissioners stated that they will take this under advisement and get back with them on this issue. Mrs. Miller then stated that they would like to ask for free water in exchange for the easement that the Commissioners requested. Mr. Lee stated that we do not get the water for free. We have to pay the city for the water. Mr. Shryock stated that we have to pay the city \$200,000 up front and then \$3.00 per thousand for the water. Mrs. Everhart asked if the Commissioners paid for easements on the sewer lines in Fresno. Mr. Fischer stated that we did. Mr. Shryock then stated that on the last line that was run to Lake Park, the Commissioners are still paying a debt retirement that the park was required to pay. That figure is approximately \$3,500 per year. Also, with this new line, they are putting a pit and meter at a cost of approximately \$4,000 to aid the park in bringing water to the camp grounds. Mr. Fischer stated that we do have a considerable investment at this time in bringing the water to the park. However, we still have to pay the city for the water that the park would utilize. The Commissioners stated that they do understand their money dilemma, and can sympathize. They will wait to hear from them after they talk with the City on this issue. The Commissioners thanked them for attending.

#### Litter Report

Mr. Jeff Wherley attended the meeting to give his Litter Report. He stated that 2011 grants have been received with a 90% pay back from the district. We will possibly be able to get a new truck for the recycling collections. He is proceeding with the specifications on this. He has received the trailer that specifically is for paper collection only. He would like to put this trailer at River View High School to see how things go. The Commissioners thanked Mr. Wherley for his report.
