Mr. Michael Gaynor and Mr. Fred Wachtel, County Engineer attended the meeting. Mr. Gaynor stated that he attended over a year ago and talked a little about some issues and he is here today to review these issues. He stated that they are proposing to increase the legal load limits on the roads by 20,000 pounds and this will impact infrastructure on the roads as well as safety on the roads. He discussed the Transportation Reauthorization bill that will continue funding for Transportation. The Transportation funding does expire on March 31st and they will have to pass the Reauthorization bill

in order for the funding to continue. He stated that within the next month or so they will vote on increasing the load limits on the roads. This vote will not be included in the Reauthorization bill. He stated that he did include a sample letter that he is asking the Commissioners to sign and send to Senator Gibbs to show the opposition for the passage of this bill. Mr. Shryock stated that we will take this under advisement. He then asked how this bill will affect the rail industry. Mr. Gaynor stated that it will affect the rail business by a loss of 20%. That being all the Commissioners thanked Mr. Gaynor for attending.
