Palmer Energy

Mr. Russ Ely, Palmer Energy attended the meeting to discuss options that Palmer Energy can offer to the county. They are attending through CCAO and they are here to help determine how to best use our gas and electricity. He stated that they have curtailment programs, which offers benefits if you are willing to curtail the use of electric or gas at certain times. These types of contracts are called Demand Response Contracts. He stated that at this point they are only asking for Coshocton County to determine if they are interested in participating in something like this. They are still in the RFP process to determine which company CCAO will recommend. He then discussed the energy assessment program. This is where they bring energy savings ideas to counties to determine what types of assessments are needed in the county and how the county would pay for the improvements. Palmer Energy would also be there to act as the general contractor for the improvements as well. The Commissioners thanked him for his information and stated that they will take this under advisement and get back with him.
