Dog License Program

Mr. Russell Dreher, Dog Warden, Mr. Mike LaVigne, Mr. Chad Lawrence, Ms. Christine Sycks, Mrs. Jinni Bowman and Ms. Danna Callahan attended the meeting to discuss the Dog Warden License Program. Mr. LaVigne stated that they have received the program and are working out the bugs and the issues. Mr. Lee asked when this was supposed to be completed. Mr. LaVigne stated that it was to be completed on September 1st, but then the programmer did not like the way it worked so he re-wrote the program and they are now working out the bugs. He then stated rather than try to work a whole new program out, they are going to utilize the old program and get through December and January and start with the new one having everything in place by June 2014. He stated that the data will just transfer to the new program. Mr. LaVigne stated that the issue has not been that the program we have in place will not work for this year, but it will not support the multiple year tags. Mr. Lawrence stated that one of the issues is the standard address. He has made an update that when an individual gets their new tag, they will update the address to make everything standard. Ms. Sycks stated that she is only worried about the satellite stores that will be selling tags. Mr. Lawrence stated that they are expecting that and at the time of transfer to the new system, they will do a cross reference and it will pick-up anyone that didn't get those addresses changed. Ms. Sycks stated that all kennel tags and multiple year tags will only be sold at the Auditor's Office. Mr. Lawrence stated that they will be able to make sure this is written in the program. The Commissioners thanked them for the update.

2014 Health Insurance Renewal

Mr. Michael Zaluski, Specialty Insurance and Ms. Valerie Shaw, Commissioners Office attended the meeting to bring the Commissioners the proposals for the 2014 renewal. He reviewed all the different options for the county. The Commissioners have elected to stay with Medical Mutual for the medical and also with CVS Caremark for the prescription. They will need to make a determination whether or not they will fund to maximum or expected claims. They will make their final determination on Monday as to what they will do.
