## Monthly Transport Expense Report

Received the Monthly Transport Expense Report for the month of May 2014 from Timothy Rogers, Coshocton County Sheriff.

## Discussion – Public Assistance

Mrs. Melinda Fehrman attended the meeting to update the Commissioners on Public Assistance. She stated that we are hearing a lot about shared services and they are part of the Canton District which consists of 27 counties and they are discussing going across county lines for shared services. That way a person could possibly apply for services or get information by just making a phone call and this would blur the county lines so to speak. She is asking for the Commissioners support for a pilot project in the Canton District. She would like Coshocton County JFS to participate in this pilot. This would allow them to look at other counties records for individuals. Rather than have just a Coshocton County Case Load, it would be a more regional case load. She feels this would be a good opportunity for Coshocton. She stated that they do not anticipate a reduction in staff if they do go forward with the regionalization of public assistance. There may be some changes to job duties though. She stated that she would very much like to be part of the pilot and there may be some cost to go to a different phone system. However, she is not certain if this would be covered by the State of Ohio or if they would be required to cover this cost. Mr. Lee asked if she knew what that cost would be. She stated that at this point she is not certain what the cost would be or even if they would be responsible for all or a portion of the cost or if the State will cover those costs. Mr. Shryock asked if the benefit would be for JFS or if it will be for the client. Mrs. Fehrman stated that she feels that the State believes this will benefit the clients. They would like the offices to use consistent processes. She does not know to what extent it will benefit the agency. Mr. Shryock asked when would this program begin. Mrs. Fehrman stated that she feels it may begin in September or October.

## Discussion 2015 Tire Day

Mr. Jeff Wherley attended the meeting to discuss the 2015 tire day with the Commissioners. Mr. Wherley stated that he is working on 2015 estimated budgets. He reviewed what he understood the Commissioners would like to do in the way of budgeting for Litter Collection, Sheriff and Health Department. He stated that he is trying to curtail costs and make savings anyway they can. With that being said, there is no money available for tire day or recycle day. He explained the monies collected for these collection days do not normally cover the cost of advertising and paying them to take tires away. He would like to stop having the annual tire day as the county loses monies on these days. Mr. Shryock asked if residents are able to take tires to a tire shop without getting new tires. Mr. Wherley stated that he is not certain, and will check on that. Mr. Fischer stated that if he understands Mr. Wherley, if funds are available we will have a tire day, but if they are not we will not have a tire day in 2015. Mr. Wherley stated that he would not like to have a tire day at all in 2015. Mr. Shryock stated that if we ever do have another Tire Day, Mr. Wherley will be expected to come into this office with a business model to make certain we can cover all the expenses for the day. Mr. Wherley stated that he will make certain to do that. Mr. Wherley thanked the Commissioners for their time.

## Schooler Family Foundation Award

After submitting an application for funding to the Schooler Family Foundation, Friday, June 6, 2014 the Coshocton County Commissioners received \$25,000 from the Schooler Family Foundation for the restoration of the Coshocton County Common Pleas Courtroom Project.
