Discussion - Mrs. Melinda Fehrman - Children Services/CSEA Funding

Mrs. Melinda Fehrman attended the meeting to discuss the funding of Children Services and Child Support Enforcement Agency. Mrs. Fehrman discussed the Child Support budget and an idea that has come to light that might help them. Until just a couple years ago they earned incentives for Child support. They would take those monies and use them as match for Federal dollars. They have stopped allowing us to do that now. This has really affected our Child Support budget. They are now short approximately \$350,000. They have taken significant steps in reducing their budget as much as possible by reducing staff. They are able to use some of their TANF funds to help with the shortfall. They will be using approximately \$110,000 of these funds. They also get CAP funding in the amount of approximately \$50,000. They are still short on these funds though. They would like to garner \$26,500 from local funds. In some counties Child Support gets funding from the County Commissioners. She does not want to ask the Commissioners for monies without giving them something in return. At present they have a contract and pay for a portion of a County Detective but it has dwindled to approximately \$30,000. She would like to increase the contract for an additional \$26,500. In return, the Commissioners would not fund that portion of the detective's salary and give those funds to Child Support and they in turn can get funds from the Federal Government. Mr. Shryock stated that if he understands this correctly, we will appropriate the monies the same as we do now, but JFS would reimburse those funds back monthly in a larger amount than they do at this time. We will have to advance Child Support the \$26,500 and they will just increase the amount paid back monthly to the general fund. The Commissioners stated that they would like to do a little more research on this and they will get back with her as soon as possible. The Commissioners thanked her for attending.

Executive Session – Litigation

At 1:00 p.m. Mr. Lee made a motion, seconded by Mr. Fischer to go into Executive session with Mrs. Tiffany Swigert, Mr. Todd Shroyer, Lt. Dean Hettinger, Lt. Jim Crawford and Mr. Jason Given, County Prosecutor to discuss litigation. All vote aye. At 1:26 p.m. Mr. Shryock returned the meeting to regular session. No action taken.
