## Dog Wardens Report

Received the Dog Wardens Report for the week ending February 22, 2016 with 2 dogs picked up by the warden, 3 dogs brought in as strays, 3 dogs destroyed, 13 citations issued, 23 calls handled, 18 dog licenses sold, 5 late fees paid, 6 dogs sold, 2 dogs redeemed, 3 dogs per owner surrender, \$25.00 in boarding fees collected for a total of \$461.00 in fees collected.

## Lead Agency Comprehensive Case Management

Mrs. Melinda Fehrman, Director DJFS attended the meeting to discuss her agency being the lead agency for the Comprehensive Core Management. Mrs. Fehrman explained that Comprehensive Case Management is for individual's ages 16-24 years of age. She is requesting that the Commissioners sign a resolution for the Coshocton County Department of Job and Family Services to serve as the lead agency for this program. It will be an additional \$171,000.00 in TANF monies. It will help the individuals in the age group above to build skills to become productive citizens. She anticipates hiring an individual to be the case manager for this program. The State would like us to start with individuals that are already on State assistance. She feels they will be able to work or contract with other agencies for this program as well.

## Resolution 2016-10

Mr. Shryock made a motion, seconded by Mr. Fischer to sign Resolution 2016-10 to designate the Coshocton County Department of Job and Family Services as the lead agency responsible for administering the Comprehensive Case Management Employment Plan.

Mrs. Fehrman then presented the Commissioners with a printout of County Shared Services Overview for the long term. The Commissioners thanked her for attending.

## Coshocton County Memorial Hospital Contract

Mr. Todd Shroyer attended the meeting at the request of the Commissioners to discuss the contract that the County has with the Hospital for transport services. Mr. Lee explained that the county is losing monies by providing this service in the amount of approximately \$160,000 this year alone. We will be notifying the hospital that we will no longer be able to provide this service after July 1, 2016. Mr. Shroyer explained that because of the changes in the ACA Regulations pertaining to Medicaid, the county is not considered an in network provider and cannot become one. So, therefore, when we transport a Medicaid patient, we do not get paid for the service. Years ago, to provide this service, monies gained permitted the county to provide an additional crew and truck for this service. However, with the new changes in the ACA regulations, the county is unable to even pay for the additional crew or any new vehicles. In the State of Ohio, it is very uncommon for a County EMS to provide this type of service. Other county agencies in the State only provide 911 services. Therefore, the Commissioners will be sending a letter to the Coshocton County Memorial Hospital informing them of our cancellation of our contract with them effective July 1, 2016.

## Executive Session – Employee Complaint

At 10:00 a.m. Mr. Fischer made a motion, seconded by Mr. Shryock to go into executive session with Mr. Todd Shroyer to discuss an employee complaint. All vote aye. At 10:10 a.m. the meeting was returned to regular session. No action taken.
