1st Public Hearing – Critical Infrastructure

Mr. John Cleek, CDC of Ohio attended the hearing. He stated that he is the Block Grant Administrator for the county. He discussed the Federal HUD Grants that are available at this time. He said the funding available this year is a little higher than expected. He reviewed the programs that the county is available to apply for this year. He stated that we are not permitted to apply for the CHIP funding this year as we applied last year and received approximately \$800,000. He reviewed the Formula Allocation funding available and regulations required to utilize this funding. He also explained that this year the county is applying for funding through the Critical Infrastructure Program for Tuscarawas Township. He stated that they actually increased the funding available this year from \$300,000 to \$500,000. The Commissioners thanked Mr. Cleek for the information and the hearing was concluded at 10:15 a.m.
