### 2<sup>nd</sup> Public Hearing CDBG Critical Infrastructure

Present for the 2<sup>nd</sup> Public Hearing for the CDBG Critical Infrastructure grant was Mr. John Cleek, CDC of Ohio. Mr. Cleek stated that the County had submitted a pre-application to the State and it was approved. The project is located in Tuscarawas Township, the project would replace an old ineffective storm drainage system. It would install approximately 3,000 LF of 12" & 18" storm sewer and 27 catch basins and one headwall. Grant applications are due June 15, 2018 for the first round of the grant cycle, however the grant is an open cycle so we can apply anytime if Tuscarawas Township is unable to get all of the information needed to submit the grant by Friday. We will be applying for \$500,000, Tuscarawas Township will be committing \$150,000 for a total project cost of \$650,000. If the application is approved we should hear back by August.
