## Senior Levy Renewal-Mr. Mike Stephens


Mr. Mike Stephens, Kno Ho Co President, Christy Neighbor, Co-Director Senior Center and Donna Denning, Vice President, attended to discuss a request to place on the November ballot a renewal with an increase to the Coshocton Senior Center levy. Mr. Stephens reviewed all the cost increases that the agency has seen in the past several years. The programs that have increased includes the number of meals that are delivered to the homebound seniors and the meals served at the center, the cost of transportation to the Center for meals and weekly grocery shopping, exercise classes and food costs. The County has an increase of 542 new seniors every year. They would like to request to place a renewal levy on the November ballot with an increase from a 1.0 mill to 1.25 mills. The Commissioners thank them for attended and stated that they would consider their request.
