In attendance were Mrs. Wanda Badgette-Dralle, Mr. Alan Dralle, Mrs. Geraldine Derringer and Mr. Fred Wachtel. The Commissioner's apologized for the late cancellation of last week's public viewing of TR 1054 due to illness. Mr. Shryock asked if anyone opposed the vacation of the road. All three in attendance are in opposition of this vacation. Mrs. Derringer is opposed due to the fact the road goes directly into the back of her barn. Mr. Dralle is opposed because his building opens to the side of the road and he would have trouble getting his hay into the building if this road is closed. Mr. Reed put up a fence in July once he bought the property and this has caused issues as the neighbors have used this road for years. The Dralle's have reached out the township for help but have not had much success there. The Dralle's had a letter that Mr. Jim Skelton had written for them to Mr. Reed telling him that the fence needs removed as it was put up without township approval. Mr. Fred Wachtel said this road is classified as an abandoned road. No action was taken today as more information is needed. The Commissioner's will have a viewing on this to determine final action on January 12, 2022.
