## From the Desk of.... Chris Sycks, Coshocton County Auditor:

Birth Pangs of a Biennial Budget

Every two years, my fellow auditors, along with the staff at the County Auditor's Association, go

through proposed budgetary changes with a fine-toothed comb. The reason we do this is because, it seems, that every time a budget bill is introduced, there are items included that could be an unpleasant surprise if passed in their initial state. While it is named a "State Operating Budget", many ideas presented can affect many different entities – including local government and Coshocton County taxpayers.

The current proposed budget is House Bill 49 and is, at the time of this article, 3,512 pages long. Besides the things listed in the "CAAO Legislative Committee Update" article on page five, the following matters of local interest are also included in all those pages:

- Changes certain rules for county veterans service commissions' directors, VSOs, and other commission employees;
- Replaces the existing Local Government Fund (LGF) direct payments to municipal corporations with a new formula;
- Moves the collection and distribution of certain business' municipal income taxes from the city or village to the state;
- Provides only for a one-time payment to counties to cover the local MCO sales tax loss for the 4<sup>th</sup> quarter of 2017;
- Removes the auditors' weekly vendor license reporting duties;
- Requires certain sales and use tax information to be published on the Department of Taxation's website;
- Changes estate tax settlements to annual instead of biannual;
- Implements a competitive transportation brokerage system for nonemergency transports, shifting control from local to state;

One of my predecessors, Richard J. Tompkins (County Auditor from 1981 to 2005), once gave these words of wisdom when I was fretting about the amount of troubles a new bill would cause: "I don't worry about any proposed bill until it becomes law." Those are good words – I would be a nervous wreck if I worried about every proposed law that was introduced. Many of these things in the budget bill will morph several times before it becomes law in July. However, keeping a jaundiced eye on a bill's progress in order to contribute opinions or voice concerns is an important part of the process – no worries, just action.

## Income Tax Refund Too High or Low?

Consider changing your withholding information by filing a new W-4 with payroll. Forms for 2017 can be found online at:

Also, it's a good time to think about any changes that have occurred or will soon occur since your last W-4 that could impact your income tax liability. Things such as a change in marital status, a new baby, a child aging out of the Child Tax Credit or dependency stage, or unusual gain or winnings could change what you owe for taxes.

Remember, you cannot claim more dependents than what your W-4 worksheet indicates, but you can ask for additional amounts to be withheld to cover unusual income.



# Spotlight on. . . COSHOCTON COUNTY DOG WARDEN

The Dog Warden's office employs three part-time Dog Wardens, whose jurisdiction reaches the city, county and all villages. Rusty Dreher, Dog Warden, has thirteen years in law enforcement along with fifteen years in fire service. Ryan Conkle, Assistant Dog Warden, has five years in both law enforcement and fire service. Steve Walsh, Deputy, has more than thirty years in law enforcement and is retired from Ohio Fab after more than forty years. All three of these employees remain on the auxiliary for the sheriff's office; however, as dog wardens, their main responsibility is covered under the Ohio Revised Code Section 955, which deals with enforcing dog license compliance, along with investigating dog running at large complaints. The dog wardens also assist other county agencies, such as the sheriff's office or EMS, with dog-related matters. As we decided to focus more on enforcement the last several years, we have seen higher compliance rates.

The dog warden's office is funded by the dog and kennel fund, which includes monies taken in for dog license, court fines, and fees collected at the animal shelter. This fund can only be used for funding dog and kennel matters. Along with enforcing license and dog at large complaints, we are statutorily required to pick up any stray dogs in the Coshocton County area. These are then housed at the Animal Shelter, which is run by The Humane Animal Treatment Association (HATA) under contract with The Coshocton County Commissioners.

Ohio Revised Code requires any dog older than 90 days to be licensed in the county he or she are housed. The license fee is \$12.00 if bought on time or \$24.00 if bought later than 30 days. If you are found not to have licenses for any age dog, you could be charged with a minor misdemeanor, which will then result in fines and court costs as well as your license fee. The only dogs who are exempt from this licensing are dogs housed at the animal shelter. The number of licenses sold has steadily increased over the years, in 2006, we sold 6756 licenses, and in 2016,

we sold 8529. Funds from o our Dog and Kennel Fund are also used to upgrade the dog warden's equipment and have been used to make some muchneeded upgrades at the animal shelter. At \$12, we are pleased to announce we rank ninth



among all 88 Ohio counties for the lowest cost of a dog license. The dog warden's office can take your complaint by calling 740-295-0026 and leaving a message.



#### AUDITOR'S SALE TO BE HELD

"Every tract of land foreclosed upon for delinquent taxes or a tax lien that has been properly offered for sale on two separate occasions, not less than two weeks apart & not sold shall be forfeited to the state & the County Auditor will offer it for sale to the highest bidder." Ohio Revised Code 5723

The next Auditor's Sale will be held at 10:30 a.m. on May 19<sup>th</sup> at the Courthouse. At the time of this article, there are five manufactured homes and five real estate parcels scheduled to be sold:

Parcels go for the best bid but may not be sold to any person delinquent on real property taxes in the State of Ohio nor for less than the total amount of charges and costs if the highest bidder is the last owner of record or his or her immediate family member.

Any taxes, charges or costs not covered by the sale will be remitted and all liens are eliminated except for the real estate taxes recovered by the sale. If there is a Federal lien, the Federal Government has "Right of Redemption" and may re-take the property for one year after the original foreclosure was filed. The buyer will receive only the amount he paid at the Auditor's sale and no more regardless of improvements done after the purchase.

A non-refundable down payment (10% of the total due or \$50, whichever is greater) is due at the sale, with the balance due within 10 days. Total due includes the bid amount, plus the fees to transfer (\$45 Auditor Deed fee, \$36 Recorder's fee & \$.50 Transfer Fee).

#### **CAAO Legislative Committee Update**

County Auditor Chris Sycks serves on the Legislative Committee of the County Auditors' Association of Ohio (CAAO), working to monitor bills that may negatively impact local taxpayers and county government, suggest legislative proposals, and encourage policies which positively impact them. With the 132<sup>nd</sup> Ohio General Assembly starting their work, we have several reintroduced and new bills. Below is information on bills of interest to the CAAO.

- HB 3 DataOhio Board Creation. Creates board and online catalog of public data, governs online public records, addresses uniform chart of accounts. In House Finance Committee.
- HB 24 Veterans Organization Tax Exemptions. To exempt from taxes all property owned by these regardless of use.
   Ist Hearing, House Ways & Means Committee.
- HB 34 Official Notice Delivery. To allow certain notifications by other than certified mail. 2<sup>nd</sup> Hearing, Senate Government Oversite & Reform Committee.
- HB 49 Operating Budget. SYF 2018-19 main budget. This includes a multitude of issues and will morph throughout the whole process until finalized in June. Items of particular interest are:
  - Addresses loss of Medicaid MCO sales tax.
  - Local Government Distribution methods.
  - Increasing state sales tax to 6.25% (with Coshocton's local tax, our county sales tax will be 7.75%).
  - Allows commissioners by resolution to authorize appointment of coroners and engineers instead of by election.

# 8th Hearing, House Finance Committee.

- HB 52 Deed Solicitation Regulation. To require certain disclosures and limits charges on mailers selling various "property records" that are public records. Passed by House; vote 96-0.
- HB 70 Fuel Tax Transparency. Requires our weights & measures inspectors to place stickers on all pumps itemizing taxes.
   Ist Hearing, House Government Accountability & Oversight Committee.
- HB 102 School Funding Reform. To replace local school levies with a statewide property tax, repeal school income taxes, require certain tax exemptions to reimburse the state for levy loss, require the Treasurer of State to issue bonds to refund school debt, among other items. In House Finance Committee.

# APPLY FOR HOMESTEAD & MORE AT THE SENIOR CENTER ON APRIL 24TH



County Auditor Chris Sycks and some of her staff will be at the Coshocton Senior Center, located at 201 Brown's Lane on Monday, April 24th, at 11:15 a.m. She will explain the Owner Occupied Reduction, the Homestead reduction and the Expanded Veterans' Homestead reduction programs and how they can save you tax dollars. She will also stay for Q & A and will be able to take applications for all the programs.

If you plan on applying for either of the Homestead reductions, please bring proof of age (driver's license) if you are 65 or older this year, or, if applying under disability, the SSI award letter. If applying for the veteran's expanded reduction, a copy of your DD214 and the letter from the U.S. Department of Veterans' Affairs documenting the disability rating will need to be presented. Veterans do not have to provide income information; all others will need a 2015 and/or 2016 income tax return or other proof of income. Anyone who has less than \$31,800 Ohio Adjusted Gross Income qualifies.





### Topic-Specific E-Courses – Taking Small Bites of the Ohio Ethics Law!

Several years ago, the Ohio Ethics Commission introduced "topic-specific" e-courses to our web site. The intent of these brief online courses was to allow public offices and agencies to compactly study specific areas of the Ethics Law.

These courses are approximately 15 minutes long and many agencies have used them at staff meetings to supplement their knowledge of the Ethics Law in short and palatable timeframes. For example, there are several agencies that show one short e-course at each staff meeting. By the end of the year, the staff has learned a great deal of information about the Ethics Law without feeling overwhelmed by information.



## 2017 OHIO SUNSHINE LAW MANUAL AVAILABLE

Lord John Emerich Edward Dalberg-Acton said "Power tends to corrupt, and absolute power corrupts absolutely."

From Patrick Henry, we heard, "The liberties of a people never were, nor ever will be, secure, when the transactions of their rulers may be concealed from them..."

And, during *State ex rel. Patterson v. Ayers*, 171 Ohio St. 369, 371 (1960), Ohio Supreme Court Justice Charles Zimmerman opined "The rule in Ohio is that public records are the people's records, and that the officials in whose custody they happen to be are merely trustees for the people; therefore anyone may inspect such records at any time, subject only to the limitation that such inspection does not endanger the safety of the record, or unreasonably interfere with the discharge of the duties of the officer having custody of the same."

Ohio legislators have put into place the 'Sunshine Laws' regarding open government to protect the citizenship to whom the government belongs. These laws are available in detail within the pages of the Ohio Sunshine Law Manual, updated every year. Part of these laws includes training and auditing. County Auditor Chris Sycks as well as several members of her office staff have completed the Public Records Training. We are also pleased to announce that Coshocton County was NOT on the list of citations from the Auditor of State's office (see press release,

#### **Coshocton DJFS News**

As Coshocton JFS wrapped up 2016, we found our foster care expenses unfortunately exceeded projections. After removing federal and shared funding reimbursements, our local obligation was \$572,513. This is over a 250% increase from the expense of 2010. Why the change? In 2010, we had a total of 29 children with an average age of 13 years old in foster and residential care. In 2016, that number climbed to 44 with an average of 8 years old. Why the change? We are finding more and more parents who are not able to keep their children safe due to their drug and alcohol abuse. Currently, we have 34 children in foster/residential care and of those, 19 families (or 56%) are abusing drugs. We are working with more and more babies who are born drug addicted which means the mothers used drugs while they were pregnant. Although the number of teens we have in our custody has decreased, most of the teenagers we work with have significant mental health issues. For example, one teen has behaviors so significant that the child has been placed in a residential facility costing \$11,000 a month. Fortunately, with the intensive treatment, we hope this teen will be able to be placed in a less restrictive environment such as foster care by the end of the year. But, placement costs in 2016 for that one child absorbed over 20% of our levy funds.

Coshocton JFS is committed to be a leader in eliminating drug abuse in our community. Not only is it a safety concern for the children affected, but it impacts the safety of every resident. We have committed Temporary Assistance to Needy Families (TANF) funds to several endeavors in the community specifically designed to reduce drug abuse and increase safety. Some of the projects include:

- Community Safety and Security Program improve safety in our county with increased visibility of and actions from the Coshocton County Sheriff's Office with an emphasis on high crime and high drug areas including the following:
  - Road officer to accompany JFS child protective workers when needed
  - Special detail for targeted enforcement traffic stops
  - Community education activities for youth and families especially in low-income housing complexes, high crime and high drug areas
  - o Interdiction detective to coordinate efforts to reduce the production, manufacturing, distribution, transportation and chronic use of illegal drugs
- Community Center Program in conjunction with Kno-Ho-Co-Ashland Community Action Commission to provide healthy no-cost

# **TANF Summer Youth Work Program Accepting Applications**

Well, it's that time of year again. Coshocton County Job & Family Services is conducting the TANF summer youth work program. Youth ages 14 to 24, who are eligible, will have opportunities to gain work experience and earn extra money over the summer.

Applications are being accepted Monday through Friday, between April 10<sup>th</sup> and May 12th, from 9 a.m. to 3 p.m. at OhioMeansJobs Coshocton County, in the lower level of Job & Family Services. The youth will start working June 19<sup>th</sup> and earn minimum wage. There will again be a need for crew leaders, so high school graduates or college students can submit a resume to Lisa Scott at:

#### What's a TIRC?

A TIRC is the Tax Incentive Review Council, and each county with any sort of tax abatements has an active council. One duty of the County Auditor is to act as chair of the TIRC, which meets annually, usually in March, to assure the projects are living up to their commitments. Coshocton County currently has two active Enterprise Zones - McWane Poles and Kraft (Heinz) Foods. McWane's is a 12-year, 100% abatement on the new construction at their site on Clow Lane. Their real estate tax bills this year would have been \$35,210 more this year had the Enterprise Zone not been in place. Kraft's is a 10-year, 75% abatement on new construction, with an added Local Job Grant that gives them some income tax relief along with their real estate tax abatement. Their real estate tax bills this year would have been \$11,871 more without the Enterprise Zone. Both of these companies have exceeded their commitment to the economic growth of Coshocton County in exchange for these tax incentives. The Port Authority works hard, along with the City and County governments to offer these incentives to bring in more jobs.

or low-cost activities for all county residents regardless of income and age. This program has been able to provide services to over 1200 residents a month at the Senior Center during the hours that the facility is not used for senior-only activities.

- Guardian Ad Litem Services through Juvenile and Probate Court for both abuse, neglect and dependency cases as well as pro se custody cases. In addition, JFS provides funding to Juvenile Court for their Diversion and Truancy Programs to proactively reduce the risky behaviors of youth in our community.
- Alternative School JFS provides funding to operate this program in lieu of suspension or expulsion. As a result, students are well supervised and able to complete coursework toward grade promotion or graduation.

These are just a few of the projects the agency supports with TANF funds. All totaled, the agency provides over \$650,000 in TANF contracts to provide needed services to the community. That's the good news. The bad news is that we cannot use TANF dollars for foster and residential placement purposes. We appreciate the fact that the commissioners have provided us with money from the general fund in exchange for some of the services listed above. Of course, we also appreciate voter support of our 1 Mil levy for child protection over the last 50+ years. This levy has been renewed every five years since 1984 and we receive about \$570,000 a year for child protection. The levy was implemented to help pay for a lot of child protective costs but as you can tell, in 2016 the funds had to be completely attributed to foster and residential care for children. In the coming months, the agency will have to make some tough decisions on how to best utilize available funding to continue to keep vulnerable children safe and help parents to do the same.
