INVITATION TO QUOTE

Coshocton County Engineer will accept sealed quotes for **2018 SALE OF SCRAP STEEL** from the Coshocton County Engineer's Office, 23194 CR 621, Coshocton, OH. Bids must be submitted each month with price quotes for the month. **Quotes must be received by the 25th of each month for the following month.** Specifications are on file and via the web at www.coshoctoncounty.net. Engineer reserve the right to reject any or all quotes. Mark all bid envelopes **Coshocton County Engineer 2018 / Month to be Bid.**

Coshocton County Engineer 2018 Sale of Scrap Steel

Per ORC 307.12, it becomes necessary from time to time for the County Engineer to dispose of materials that are not needed for public use, are obsolete, or are unfit for the use for which they were acquired. Because the estimated annual value of scrap steel sold by the County Engineer exceeds \$2500, it is necessary for the County to sell the material per sealed bids. Following are the specifications and procedures that will be used to sell these materials.

SPECIFICATIONS

1. The successful bidder shall either have a facility within five miles of the Coshocton County Engineer's Office located at 23194 CR 621, Coshocton, Ohio 43812, or will provide appropriate containers at said location for various materials that will be bought. Containers are to be placed and picked up by the successful bidder at the end of each calendar month. More often if the quantity of material warrants.
2. The successful bidder shall be required to provide **printed** (not hand-written) weigh tickets for all loads delivered by County personnel to the bidder's facility and for any containers that may be provided by the successful bidder.

PROCEDURES

1. Prices paid to the County will be established on a monthly basis. Sealed bids will be accepted no later than the 25th of month for each different material for use during the following month. The sealed bids must be delivered to the County Engineer's Office by 4:00 p.m. on the 25th, or if the 25th is a Saturday or Sunday, the preceding Friday.
2. The County will deliver the various materials to the highest bidder for that item during that month. Or, place the material in bidder supplied containers at the County Engineer's Office.
3. The County does not guarantee to deliver any minimum quantity of material; any scrap generated is dependent upon the activities of the County Engineer in any particular month.
4. The monthly prices will be submitted on the following form:
