

**Coshcocton County
Specifications for the Purchase of
One (1) Used Forestry Bucket Truck**

General:

1. Unit must meet all minimum specifications. Any exceptions to these minimum specifications must be clearly noted on the sheet titled "Exceptions to the Specifications" and submitted with the bid. Bidders may provide bids for multiple units if available for consideration.
2. Bidder may submit prices for a used forestry bucket truck meeting these specifications. Used units shall be a 2018 model year or newer and have maximum 50,000 miles.
3. If the unit is located greater than 100 miles from 23194 County Road 621, Coshocton, Ohio 43812, bid price shall include F.O.B. to 23194 County Road 621, Coshocton, Ohio 43812.
4. All bids to be submitted in a sealed envelope marked "Used Forestry Bucket Truck, February 23, 2026" and must be received **before 9:00 am on February 23rd, 2026** at the office of the Board of Coshocton County Commissioners, 401 1/2 Main St., Coshocton, Ohio 43812.

2. Min. 75 FT. Working Height Bucket
3. 6.7 Cummins Turbo Diesel Engine
4. 6 Speed Manual Transmission
5. Max 50,000 Miles
6. Cab Protector
7. 11 Ft. Chipper Dump Bed
8. Min 50 Gallon Fuel Tank
