Steps for homeowners to obtain sewage permits

- 1. Property owners contacts a **soil evaluator** to obtain a "site and soil evaluation" that accurately describes the lot and soil characteristics.
- 2. Property owner takes site and soil evaluation report to a system designer who will design a sewage treatment system based on the site and soil evaluation and the homeowner's particular plans and needs.
- **3.** The property owner then submits a "<u>Site Review Application</u>" along with <u>both copies</u> of the completed site and soil evaluation and the completed system design to the health department.
- **4.** Health Department staff will review the application and accompanying information to determine whether the proposed plans are applicable and in compliance with the rules and regulations.
- 5. After the application has been approved, the property owner can then obtain an <u>installation permit</u> from the health department to have the sewage treatment system installed by a registered contractor.
- 6. After the system is installed, the installer and designer will provide an "as built record" and warrant that the system was installed according to the approved plan.
- 7. The health department will then inspect the installation and approve the as built record.
- 8. The property owner will be issued an **operation permit** to use the sewage system. Operation permits are valid for five years and must be renewed by the health department.
- 9. **Keep all records or pumping information** as part of the operation and maintenance tracking program. Recommend to pump every 2-3 years based on usage
