

Public Health Accreditation was developed to standardize and improve the quality of health districts across the country. Under Governor John Kasich it was signed into legislation for Ohio Health Departments to meet this standard. The Public Health Accreditation Board (PHAB) along with 4,000 public health experts, developed this process to measure performance against a set of standards based on the "Ten Essential Public Health Services".

Accreditation challenges us to think about what we do and how we do it using tried and true methods. Accreditation also brings the recognition of reaching these high standards. The more efficient a health district is, the more effective we can be at doing our work – with an ultimate goal of protecting the health of the community and improving lives.

Coshocton Public Health District is proud to say we have been working diligently over the past year in preparation to apply to the PHAB. The work does not stop with the application, we will spend the next twelve months developing, defining, and refining our overall missions, values and vision for the public health services provided to the county and how our workforce can grow to continue to be the recognized leader in community health.

COVID-19 RESPONSE EFFORTS

During 2023, Coshocton Public Health District continued with efforts to help minimize the spread of COVID-19 and prevent severe illness and hospitalization through the provision of home antigen test distribution, vaccine clinics, regular health communication messages, and more. While the effects of COVID-19 have not stopped, we are thankful to see less cases and hospitalizations among Coshocton residents thanks to vaccine protection and more advanced treatment options.

This includes how to recognize the signs and symptoms of an overdose and how to use naloxone to quickly reverse an overdose caused by an opioid drug.

2023 Environmental Health

Environmental health focuses on the relationships between people and their environment; promotes human health and well-being; and fosters **healthy and safe communities**. Environmental health is a key part of any comprehensive public health system.



Food service and Retail food establishment licensing

and inspection, including restaurants, school cafeterias, gas stations, food concessions, grocery stores, and vending machines. Also included, **Mobile food trucks** and **Temporary food** licensing and inspections. We also investigate food borne illness complaints and Outbreaks.

Household sewage treatment of systems for

new development and for upgrades/repairs for existing homes.

Designs and soil work are approved for installations/permitting. Our department reviews and approves new lot proposals, and registers sewage system installers, septage haulers and service providers.



HSTS Assistance Funding Program- \$150,000 Awarded for 2023. (Remaining (\$99,684.20) funds can be used up until December of 2024.

\$118,393.55 was requested in 2023 (from grants 22' and 23') for repairs and replacement systems. Homeowners seek eligibility based on income levels of the home. Funding tiers include 100%, 85%, and 50% coverage of a total project cost.



Private water systems are sited, permitted, and approved samples are collected from new and existing systems in order to determine safety, and potable water haulers are registered and inspected.

Recreational vehicle parks and campgrounds are licensed and inspected, including resident day camps.

Manufactured home parks are licensed through the Ohio Department of Commerce and inspections are completed and contracted through us.

Public swimming pools are licensed and inspected, including special use pools and hot tubs to ensure proper water quality and safety for the guests.





Nuisance complaints are received and investigated in a timely fashion.

Tattoo and body piercing facilities are approved and inspected.

Solid Waste program includes the inspection of landfill facilities, tire retailers, compositing facilities, solid waste hauler inspection, open burning and open dumping violations.



Mosquito Surveillance involves sending in mosquitos to the state lab to track areas with a positive West Nile Virus mosquito population. Education is provided to the public abou protection/prevention through our social media outlets.

Rabies Surveillance in conjunction with USDA, collect and submit samples to USDA for rabies testing/tracking.



Animal Bite Investigations reports are received from hospitals and dog wardens of bites, our office follows up with the owner and notifies by letter to verify rabies vaccinations and the health of the dog.

Infectious Waste inspections of small and large generators of infectious waste.

Regional Planning- Lots are evaluated in regards to septic and well locations and any physical attributes associated with the lot. Each lot planned for a home site is required to have soils evaluation and septic system design for permitting purposes.



<u>New Well Installations</u>- (72) Every well gets sampled for a bacterial analysis by CPHD. Also perform well certifications for real estate transfers.

<u>New/Replacement Sewage Treatment Systems</u>- (82) Every set of plans get reviewed on site and perform installation inspections on site before final coverage. Also perform sewage certifications for real estate transfers

<u>Landfill Licenses</u>- (2) Coshocton Landfill and Alberts C&DD Landfill. Each facility gets (6) inspections per year. CR 38 RockTenn Landfill inspected Annually

<u>Lot Split Reviews</u>- (370) Lot splits are evaluated to confirm locations of well and septic and any other physical attributes and or restrictions. Splits come from Coshocton County Regional Planning Commission.

<u>Swimming Pool Licenses</u>- (14) Pools get inspected (2) twice per season for water quality parameters and safety requirements.

Campground Licenses - (11) Inspected (2) times per season.

Tattoo Facility Licenses- (6) Inspected (1) once per year

Manufactured Home Parks- (12) Parks are licensed by Ohio Department of Commerce. CPHD is contracted to perform inspections starting in July of 24'.

License Water Hauler Trucks- (2) Millcreek Water Hauling, Wild Water

<u>License Trash Haulers</u>- (4) Geer Services, Kimble Recycling, Aronhalt Hauling, Ohio Dumpster Rentals, Coshocton Trucking (prevention of nuisances)

License Septic Haulers (12), Septic Installers (25), & Service Providers (6)

<u>Complaints</u>- On Average we received about **65-75** complaints a year. The complaint is handled usually within 5 working days to determined validity. Complaints that are a threat to public safety are handled more immediate. Residents are given a timeframe for cleanup if necessary.




Snapshot of our WIC Participants

All are required to be completed in office. These are typically on a 3-month cycle to have their foods loaded to their WIC Nutrition Card (WNC).


Nutrition education is the focus of all WIC visits.

Fiscal Year 2023 WIC Caseload and Certified Participants:


State WIC Assigned our caseload as 514 participants.

- Breastfeeding mothers up to a year
- Post-Partum Women up to 6 months
- Pregnant Women

Increasing Breastfeeding Rates in 2023 Among Newborns:

- 61% of all Certified WIC infants initiated breastfeeding.
 - 44% were breastfeeding >/ 1 month old
 - 32% were breastfeeding >/ 3 months old
 - 24% were breastfeeding >/ 6 months old
 - 11 % were breastfeeding >/12 months old

WIC is committed to promoting, supporting, and protecting breastfeeding. We continue to have Certified Lactation Counselors (CLC) on staff, participate in the Breastfeeding Peer Helper program.

Coshocton Public Health District (CPHD) has been an OBB program site since August 14, 2020. The Ohio Department of Health's OBB program provides child safety seats and boosters to eligible families. The goal is to increase availability of seats and increase correct installation, proper use of child safety seats.


Families must meet these requirements to receive a car seat from CPHD's OBB program:

- Reside in Coshocton County
- Custody of a child birth to 8 years-old and/or expecting a child (within 30 days of due date)
- Income eligible within WIC Program guidelines, but does NOT have to be WIC enrolled
- Educations provided through completing the online module via carseateducation.org. If unable to pass, hands on education is provided by Car Seat Passenger Safety Technician (CPST).
