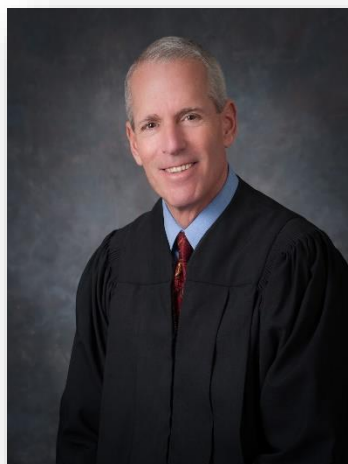

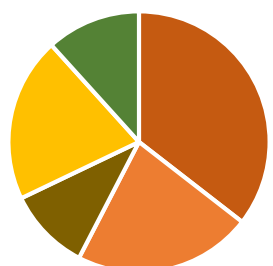

GENERAL FUND BUDGET BY CATEGORY

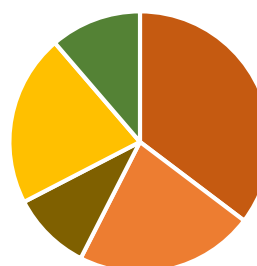

SPECIALIZED DOCKETS & RELATED PROJECTS

Family Dependency

Drug Court:



Certified in 2014 as a Specialized Docket, was one of the first 15 courts of this type in Ohio. 34 individuals served through 2017, with 9 successful graduates and 14 clients enrolled at year-end. Intensive Focus on Child Welfare parents that have substance addiction issues. Parenting, Education, Treatment, Employment and Self-Sustainability, with appropriate permanency for children are the ultimate goals.

Juvenile Drug Court:



Started in 2002, Certified as a Juvenile Specialized Docket Program since 2014, has served over 59 youth. Only youth with the most serious addiction issues gain admission into this docket. 30 youth have graduated successfully, 9 were served in 2017. To date, two scholarship awards to one successful graduate allowed completion of HVAC certification training after high school graduation.

Statewide System Reform Project



Selected by the Supreme Court of Ohio as a Phase 1 Pilot Site to test best practice infusion strategies related to child welfare involved cases with substance abuse issues. Implemented 7 day a week drug testing, UNCOPE early screening, and enhanced review for early identification and engagement in the FDC Program. Over 100 clients tracked for FDC referral and 147 parents screened, 73 referred for additional assessments.

Friends of Coshocton County Drug Court, Inc.



A not-for profit organization that supports the efforts of the Specialized Docket Drug Court Programs at the Juvenile Court. Norm Davitt Memorial Scholarship is available from the Coshocton Foundation for youth that successfully complete their program to gain college or job skills training. Received Community Impact Funds from the local United Way of Coshocton County in 2017, also provides training, incentives, and challenge funds for successful graduates in the Specialized Docket Programs. The Board consists of local Agency, Business, Education, Law Enforcement and other interested community citizens that also provide oversight to other court grant projects and programs.

OTHER PROBATE & JUVENILE PROGRAMS

Family Law Clinic



This monthly free clinic serves individuals with limited income by providing access to attorneys for brief advice related to civil filings including custody, divorce, visitation and other issues. Southeastern Ohio Legal Services screens clients and assist local attorneys to provide this service. 12 Attorneys served 12 clinics and 102 qualified clients of the 129 screened in 2017.

Juvenile Court Self-Help Legal Support



Juvenile Court expanded legal services through an agreement signed with Capital University's Family and Youth Law Center allow income-qualified clients to get assistance beyond what the Court's brief advice legal clinic is able to offer. Services from Capital include a phone help-line, a self-help page related to Juvenile Court's forms and process, and limited on-site law student assistance.

TANF Guardian Ad Litem Services



Started in 2013, limited Guardian Ad Litem services allow for enhanced information in custody cases that previously was reserved for only for cases in which parties could pay for these services. Approximately 100 cases per year receive this benefit, which allows for informed decisions from the bench.

Juvenile Diversion Program Competitive Reclaim Grant



A revised Juvenile Delinquency and Unruly Diversion Program began in July 2017, after an award of a Category I Competitive Reclaim Grant from the Ohio Dept. of Youth Services. Case Western Reserve University compiles outcome data, and compares youth scores on surveys using OYAS risk levels, Ohio Scales, and Nurturing Parent curriculum with families.

TANF Probation Projects Truancy & Diversion



Coshocton County DJFS collaborated with Coshocton Juvenile Court to provide Truancy and Diversion Services for a portion of 2017 due to a loss of grant funding for these services until other funding was budgeted or awarded. Success measures targeted school attendance and performance. 58 Official and 191 unofficial cases were tracked in this project.

OTHER PROBATE & JUVENILE PROJECTS

2017 Summer Records Project



A site supervisor and (2) summer youth workers helped the Court to organize, index and consolidate a large number of records and provide an accurate mapping and rotational system for records management.

Some 13,644 cases were logged and 11,652 that were eligible for sealing and expungement were removed from the Main Courthouse storage areas. These records included: 1,992 Abuse, Neglect and Dependency cases from 1907-199 / 7,942 Delinquency, Contributing and Unruly cases from 1906-1986 / 3,710 Traffic, Delinquency and Unruly cases from 1968-1998.

In addition to the above work: 25 boxes of trash and old paperwork from the attic of the Main Courthouse was able to be destroyed, the staff assisted the County Commissioners Office with re-organizing their storage area at the County Records Building, 40 boxes that were previously damaged were re-boxed at the Records Building.

To finish the summer, equipment was gathered for auction, they copied Marriage License Index Books to convert to Digital format, Re-indexed and organized Probate records at the County Storage Building from 1811-2010, and transferred 45 boxes into new space which are scheduled for sealing and expungement.

Guardianship Training



Coshocton County Probate Court encourages guardianship training for all guardians, and provides both local sites for training as well as flash drives and website resources for training of all local guardian providers.

In October over 50 guardians attended training on medications and medical advocacy at the COTC Campus. Approximately 203 local guardians have completed coursework pursuant to recent Ohio Guardianship updated educational requirements.

Community Service



Court involved youth assisted many Community group work projects including: Pomerene Center Chocolate Extravaganza, Word Worship Center, Women of Witness, Clean up Coshocton, Kiwanis Food Pantry (x3), Human Trafficking Awareness at First Fridays (x2), Family Fun Event at Court Square, Harvest Party at Community Center, Christmas Bazaar, United Way Taste of Coshocton County, Coshocton Lake Park Clean up and countless other individual assignments.

OTHER PROBATE & JUVENILE PROJECTS

Technology Systems Upgrades



Henschen & Associates

Our Court received Grant Funding from the Supreme Court of Ohio to work with Henschen & Associates, the Court's Case Management System Vendor, to become their first Juvenile-Probate Court in Ohio of some 48 Counties serviced to allow for E-filing, paperless processing, and paper-on-demand processing. The Court continues technology enhancement efforts for ease of access, efficiency, and planning for future projects. Past technology projects include off-site backup systems, new servers, updated recording systems, and enhanced camera and security equipment.

High School Mock Trial



21 Local Youth on (2) teams competed in 2017-18 Ohio High School Mock Trial Competition. Judge Van Blanchard II, Judge Robert J. Batchelor, County Prosecuting Attorney Jason Given and Assistant Prosecutor Christie Thornsley work with Coshocton County youth each year on weekends and evenings for preparation of competition. One team has been to Regional Competition the past two years, narrowly missing advancement to state competition. The program has been in existence for 4 years in Coshocton County.

PROGRAMS & SERVICES FOR COURT INVOLVED YOUTH – 2017

Numerous programs and services are in place for youth that have contact with the Juvenile Justice System in Coshocton County. Collaboration with community partners, sharing of services, and evidence-based programming to assist with rehabilitation and competency development of identified youth is only a fraction of the services available. The services below is not an exhaustive list of services, but a general description of programming for youth served in our county.

Duration of Involvement: Length of time for court involvement in all cases is determined by offense level, youth and family compliance, completion of programming, and completion of identified goals. Additional assessment and services may be provided if specific concerns are identified. Approximate timeframe guidelines are listed below:

Truancy & Unruly: (4-6 months) Progress on attendance and behaviors which led to system referral.

Delinquency Diversion: (4-6 months) Progress and completion is determined by completing contract goals and educational programming. Parental involvement is critical and also an 8 hour community service component is included along with school performance and behavior monitoring.

Probation: (6-18 months) Youth on probation range from misdemeanor youth that have previously been in diversion or felony offense youth that are on specialized probation due to the nature of the offense or other mental health or addiction needs.

Diversion Services: Identified youth with unruly, truancy, or first –time delinquency charges are considered diversion eligible if after locally developed incremental interventions are not successful. Services may include: contracts, community service, curfew, apology letters, alternative school referral, mental health assessment, parental & youth educational sessions, drug screening & assessment, domestic violence programming, texting and sexting programming, and a host of other front-end less intensive services are provided based on needs assessment and case planning by diversion and truancy staff. Ohio Youth Assessment and Ohio Scales survey monitoring are a portion of the quality assurance for specific programs, and other measures are also implemented for specific programming.

Attorney Representation: Over 90% of all youth coming into the Juvenile Court system in Coshocton County are represented by legal counsel at their initial appearance hearing and all subsequent hearings and reviews. Hearing types may include: detention hearings, initial appearance for arraignment on a misdemeanor or felony cases, case reviews, or discharge from probation hearings.

Probation Services: Various levels of probation service is provided to youth, and the Ohio Youth Assessment System is one tool that is used to determine the level of probation supervision. Other considerations include: offense type and seriousness, community risk factors, level of treatment services needed, and the ability to monitor compliance. Many youth receive mental health or substance use assessments and weekly meetings to discuss youth at risk of or in need of placement occurs with agency partners. Probation Services generally includes: community service, curfew monitoring, school attendance and achievement monitoring, treatment program compliance, drug testing, specialized services including specialized probation for youth with high risk behaviors, including sexual, violence and drug or alcohol issues. Regular court case reviews are held for specialized cases. High Fidelity Wrap-around and Case Management is available for family supports.

Other Services & Programs: Numerous programs and additional services are available through local providers and some may be funded by eh Court with program dollars from the Ohio Department of Youth Services. A portion of these are listed below:

Traffic Seminar: Program presentation developed for juvenile traffic offense violations, includes a presentation about distracted driving, impaired driving and consequences of poor decisions. A presenter and state trooper facilitate discussion and parents and youth participate in this mandated program for traffic offenders.

Clinical Assessment: Assessments for specialized sex offender treatment, intensive treatment program updates, competency, amenability , restoration to competency are all provided and funded for youth if identified

Electronic Monitoring: GPS Technology allows the Court to track youth in real time with these devices, and 3 units are owned by the Court. Exclusionary zones may be created for protection of crime victim purposes and staff can check on attendance at required meetings. In addition, 16 traditional electronic monitors are owned by the Court for monitoring through a traditional telephone system.

Drug Testing: Portable sobrietyors for instant alcohol testing, instant device drug testing, and laboratory services are for youth, adults, and other cases monitored by the Court. Over 1,542 test results were logged into the Court Case Management System last year, which is used to monitor all official drug court, probation, and diversion youth tests. Additional testing for civil docket cases and abuse/neglect/ dependency cases are not entered into this system. Results of entered testing indicates:
