Thank you for the honor of allowing me to serve you as the Probate and Juvenile Court Judge in Coshocton County!

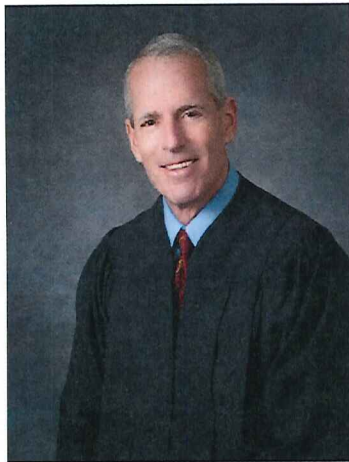

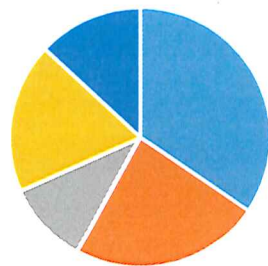

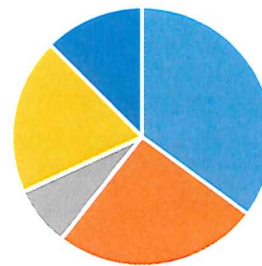

## PROGRAMS & SERVICES FOR COURT INVOLVED YOUTH – 2018

Numerous programs and services are in place for youth that have contact with the Juvenile Justice System in Coshocton County. Collaboration with community partners, sharing of services, and evidence-based programming to assist with rehabilitation and competency development of identified youth is only a fraction of the services available. The services below is not an exhaustive list of services, but a general description of programming for youth served in our county.

**Duration of Involvement:** Length of time for court involvement in all cases is determined by offense level, youth and family compliance, completion of programming, and completion of identified goals. Additional assessment and services may be provided if specific concerns are identified. Approximate timeframe guidelines are listed below:

**Truancy & Unruly:** (4-6 months) Progress on attendance and behaviors which led to system referral.

**Delinquency Diversion:** (4-6 months) Progress and completion is determined by completing contract goals and educational programming. Parental involvement is critical and also an 8 hour community service component is included along with school performance and behavior monitoring.

**Probation:** (6-18 months) Youth on probation range from misdemeanor youth that have previously been in diversion or felony offense youth that are on specialized probation due to the nature of the offense or other mental health or addiction needs.

**Diversion Services:** Identified youth with unruly, truancy, or first –time delinquency charges are considered diversion eligible if after locally developed incremental interventions are not successful. Services may include: contracts, community service, curfew, apology letters, alternative school referral, mental health assessment, parental & youth educational sessions, drug screening & assessment, domestic violence programming, texting and sexting programming, and a host of other front-end less intensive services are provided based on needs assessment and case planning by diversion and truancy staff. Ohio Youth Assessment and Ohio Scales survey monitoring are a portion of the quality assurance for specific programs, and other measures are also implemented for specific programming.

**Attorney Representation:** Over 90% of all youth coming into the Juvenile Court system in Coshocton County are represented by legal counsel at their initial appearance hearing and all subsequent hearings and reviews. Hearing types may include: detention hearings, initial appearance for arraignment on a misdemeanor or felony cases, case reviews, or discharge from probation hearings.

**Probation Services:** Various levels of probation service is provided to youth, and the Ohio Youth Assessment System is one tool that is used to determine the level of probation supervision. Other considerations include: offense type and seriousness, community risk factors, level of treatment services needed, and the ability to monitor compliance. Many youth receive mental health or substance use assessments and weekly meetings to discuss youth at risk of or in need of placement occurs with agency partners. Probation Services generally includes: community service, curfew monitoring, school attendance and achievement monitoring, treatment program compliance, drug testing, specialized services including specialized probation for youth with high risk behaviors, including sexual, violence and drug or alcohol issues. Regular court case reviews are held for specialized cases. High Fidelity Wrap-around and Case Management is available for family supports.



## PROGRAMS & SERVICES FOR COURT INVOLVED YOUTH – 2018

**Other Services & Programs:** Numerous programs and additional services are available through local providers and some may be funded by the Court with program dollars from the Ohio Department of Youth Services. A portion of these are listed below:

**Traffic Seminar:** Program presentation developed for juvenile traffic offense violations, includes a presentation about distracted driving, impaired driving and consequences of poor decisions. A presenter and state trooper facilitate discussion and parents and youth participate in this mandated program for traffic offenders.

**Clinical Assessment:** Assessments for specialized sex offender treatment, intensive treatment program updates, competency, amenability, restoration to competency are all provided and funded for youth if identified

**Electronic Monitoring:** GPS Technology allows the Court to track youth in real time with these devices, and 3 units are owned by the Court. Exclusionary zones may be created for protection of crime victim purposes and staff can check on attendance at required meetings. In addition, 16 traditional electronic monitors are owned by the Court for monitoring through a traditional telephone system.

**Drug Testing:** Portable units for instant alcohol testing, instant device drug testing, and laboratory services are for youth, adults, and other cases monitored by the Court. Over 1,542 test results were logged into the Court Case Management System last year, which is used to monitor all official drug court, probation, and diversion youth tests. Additional testing for civil docket cases and abuse/neglect/ dependency cases are not entered into this system. Results of entered testing indicates:

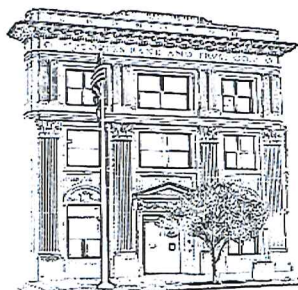
