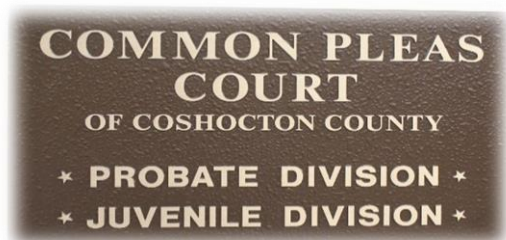

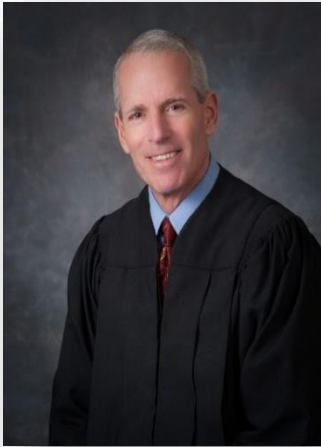

## **2019: A YEAR IN REVIEW**

### **Quarter 1 & 2**

Coshocton Juvenile Court for the 5<sup>th</sup> consecutive year sponsored 16 local youth on 2 teams in the annual Ohio Mock Trial Competition, with the Scarlet Team advancing to Regional Competition. The competition focused on Fourth Amendment protections and unreasonable searches and seizures as it applies to technology.



Judge Van Blanchard II led a presentation to Court and Child Welfare in the Southeast Ohio Region on the Statewide System Improvement Program. Coshocton's Court was one of 7 Phase One Pilot Sites that have worked for 3 years on Court and Child Welfare System Improvements related to early identification of substance use and implementing best practices in court and child welfare cases. A Federal Grant has provided ongoing support for these efforts.

As one of 15 sites in the U.S. chosen to test strategies for developing systems to identify infants and toddlers impacted by parental substance use and exposure, Coshocton's QIC Team hosted world renowned pediatric researcher Dr. Ira Chasnoff for an all-day presentation to over 100 local providers. The Quality Improvement Center and Children and Family Futures is assisting in this 3 year project to develop strategies for communities in implementing Plans of Safe Care as mandated in the Comprehensive Addiction and Recovery Act of 2016. Several Ohio state level agencies provide oversight and technical support.



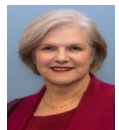
Supreme Court of Ohio Justice Judith French presents a Technology Grant Award to the Probate & Juvenile Court to enhance and replace the main courtroom video system that was built in 2010. The Probate and Juvenile Court has received technology and security funding from the state for multiple projects in the past 4 years to improve access & efficiency!

National Drug Court Month was celebrated with a Graduation from the Family Dependency Court Program on May 15, 2019. Coshocton County's Program has received national attention, with visits from Ohio State Agencies, the Supreme Court of West Virginia, and numerous county jurisdictions in Ohio. Through 2019, 31 participants have successfully completed.



Supreme Court of Ohio Chief Justice Maureen O'Connor applauded Coshocton County Juvenile Court for its Truancy Intervention Programming, which is listed as an evidence based and evidence informed practices to curtail attendance issues in the county. Court staff meet regularly with all county districts and track K-12 attendance at all schools!

Nancy K. Young, Ph.D., MSW, Executive Director of Children and Family Futures, testified to the U.S. House of Representatives – Comm. on Oversight and Reform as a Medical Expert and the inadequate federal approach to Opioid Treatment and need to expand care. Testimony centered on her Coshocton visit, and creative approaches for client success in a small rural setting.



### **Quarter 3 & 4**



A presentation at the Addiction Studies Institute, a national conference sponsored by OSU Wexner Medical Center about implementing best practice in a rural setting was made by 5 members of the Coshocton QIC Collaborative Community Court Team.

12 Members of the Court's Quality Improvement Core Team attended the 2<sup>nd</sup> National QIC Meetings in Newport Beach, CA, to report and learn from the 15 sites and topic experts from across the country.

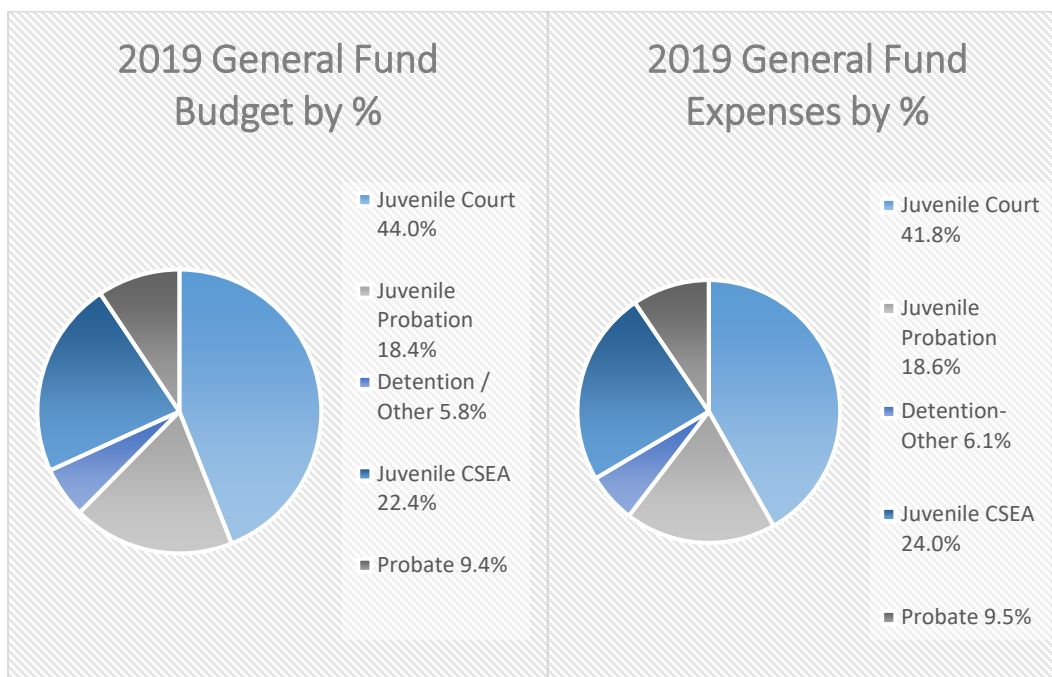


Dr. Kristie Brandt, CEO of the Parent-Infant & Child Institute was sponsored for training of some 100 local agency staff & providers on Infant-Family & Early Childhood Mental Health. A focus was on trauma and how to overcome barriers in working with families of impacted children.

Judge Blanchard, Magistrate Kalis and staff began a comprehensive review of Local Probate and Juvenile Rules and incorporating additional best practice measures for family services. The Court continues to expand legal services and online access to information for the public.

## SPECIALIZED DOCKETS & RELATED PROJECTS

### Family Dependency Drug Court:



Certified in 2014 as a Specialized Docket, was one of the first 15 courts of this type in Ohio. Over 160 clients have been tracked for inclusion since inception with over 35 successful graduates. In 2019 there have been 9 successful graduates, 7 unsuccessful terminations, 2 neutral terminations and 31 clients served. Parents with addiction issues in open child welfare cases develop individualized plans for enhancing parenting skills, treatment, employment, and sustainability with permanency & safety for children as ultimate goals.

### Juvenile Drug Court:



Started in 2002, Certified as a Juvenile Specialized Docket Program since 2014, has served over 61 youth with serious addiction issues. 31 youth have graduated successfully, and all involved made progress in various areas of functioning, but were not able to complete 100% of program requirements. To date, two scholarship awards have been given to allow for post-secondary education.

### Statewide System Improvement Project



The final year as a Phase 1 Pilot Site to test best practice infusion strategies related to child welfare involved cases with substance abuse issues has led to many accomplishments for our Court and the state. Implementation of 7 day a week drug testing, UNCOPE early screening from 2016-2019 and enhanced early engagement strategies in the FDC Program. Over 160 clients tracked for FDC referral and over 900 parents have been early screened for possible services.

### Friends of Coshocton County Drug Court



A not-for profit organization that supports the efforts of the Specialized Docket Drug Court Programs at Juvenile Court. The Norm Davitt Memorial Scholarship is available from the Coshocton Foundation for successful clients to gain college or job skills training. Community Impact Funds from the local United Way of Coshocton County in 2019 provides Healthy Relationship classes and assists with drug screening for clients in the Family Court Programs. The Board consists of local Agency, Business, Education, Law Enforcement and other interested citizens & acts as an advisory board for various grant projects of the Court.



## SPECIALIZED PROGRAMS & FAMILY SERVICES

### QIC Court Team



In 2018 Coshocton was one of 15 sites selected to receive federal funding to develop and implement strategies for Plans of Safe Care for families with children affected or exposed to parental substance use or diagnosed with Fetal Alcohol Syndrome. The Collaborative Court Team has worked to identify families early, incorporate a plan of safe care for children 0-3, and promote best practice & services for trauma informed treatment in a rural community. Data collection and evaluation are mandatory components of this work. For 2019, 183 children and 151 adults were identified for services with a total of 214 Releases signed!

### Family Law Clinic



This monthly free clinic serves individuals with limited income by providing access to attorneys for brief advice related to civil filings including custody, divorce, visitation and other issues. Southeastern Ohio Legal Services screens clients and assists local attorneys to provide this service. 14 area Attorneys served 12 clinics and 111 qualified clients of the 129 screened in 2019.

### Court Help Center Attorney & Legal Support



The Supreme Court of Ohio

The Supreme Court of Ohio provided funding to equip a Legal Help Center that provides additional assistance to Court Clients. The Clinic Office is used for monthly clinics, but also serves as a hub for contracted legal assistance for Juvenile Court Clients that can review forms and discuss filings with an attorney to have a more thorough understanding of the Court Process. In 2019, 27 clients met with an Attorney in the Help Center.

### TANF Guardian Ad Litem & Court Investigator Services



In 2019, limited Guardian Ad Litem services allow for enhanced information in custody cases that previously was reserved for only for cases in which parties could pay for these services. In addition, a Parenting Service Coordinator and Court Investigator were added to assist with connecting families to services and providing information for meaningful dispositions.

### Juvenile Diversion Program Competitive Reclaim Grant



The Supreme Court of Ohio



Delinquency and Unruly Diversion Programs continued in 2019, after an initial award of a 3 year Category I Competitive Reclaim Grant from the Ohio Dept. of Youth Services in 2017. Case Western Reserve University compiles outcome data, and compares youth scores on surveys using OYAS risk levels, Ohio Scales, and Nurturing Parent curriculum with families. The Court's Diversion Program received recognition by the Supreme Court of Ohio as a program that uses evidence informed practices in working families to provide meaningful results.

## PROGRAMS & SERVICES FOR COURT INVOLVED YOUTH – 2019

Programs and services are in place for youth that have contact with the Juvenile Justice System in Coshocton County. Collaboration, community partners, sharing of services, and evidence-based programming to assist with rehabilitation and competency development of identified youth is only a fraction of the services available. The services below is not exhaustive but a general description of programs for youth in our county.

**Duration of Involvement:** Length of time for court involvement in all cases is determined by offense level, youth and family compliance, completion of programming and identified goals. Additional assessment may be provided if specific concerns are identified. Approximate timeframe guidelines are listed below:

- **Truancy & Unruly:** (4-6 months) Progress on attendance and behaviors which led to system referral.
- **Delinquency Diversion:** (4-6 months) Progress and completion is determined by completing contract goals and educational programming. Parental involvement is critical and also an 8 hour community service component is included along with school performance and behavior monitoring.
- **Probation:** (6-18 months) Youth on probation range from misdemeanor youth that have previously been in diversion or felony offense youth that are on specialized probation due to the nature of the offense or other mental health or addiction needs.

**Diversion Services:** Youth with unruly, truancy, or first –time delinquency charges are considered diversion eligible if locally developed incremental interventions are not successful. Services may include: contracts, community service, curfew, apology letters, alternative school referral, mental health assessment, parental & youth educational sessions, drug screening & assessment, domestic violence programming, texting and sexting programming, and a host of other front-end less intensive services are provided based on needs assessment and case planning by diversion and truancy staff. Ohio Youth Assessment and Ohio Scales survey monitoring are a portion of the quality assurance for specific programs, and other measures are also implemented for specific programming.

**Attorney Representation:** Over 95% of all youth coming into the Juvenile Court system in Coshocton County are represented by legal counsel at their initial appearance hearing and all subsequent hearings and reviews. Hearing types may include: detention hearings, initial appearance for arraignment on misdemeanor or felony cases, case reviews, or discharge from probation hearings.

**Probation Services:** Various levels of probation service is provided to youth, and the Ohio Youth Assessment System is one tool that is used to determine the level of probation supervision. Other considerations include: offense type and seriousness, community risk factors, level of treatment services needed, and the ability to monitor compliance. Many youth receive mental health or substance use assessments and weekly meetings to discuss youth at risk of or in need of placement occurs with agency partners. Probation Services generally includes: community service, curfew monitoring, school attendance and achievement monitoring, treatment program compliance, drug testing, specialized services including specialized probation for youth with high risk behaviors, including sexual, violence and drug or alcohol issues. Regular court case reviews are held for specialized cases. High Fidelity Wrap-around and Case Management is available for family supports.

## PROGRAMS & SERVICES FOR COURT INVOLVED YOUTH – 2019

### Other Services & Programs:

**Traffic Seminar:** Developed for juvenile traffic offense violations, includes a presentation about distracted driving, impaired driving and consequences of poor decisions. A presenter and state trooper facilitate discussion and parents and youth participate in this mandated program for traffic offenders.

**Clinical Assessment:** Assessments for specialized sex offender treatment, intensive treatment program updates, competency, amenability, restoration to competency are available for youth.

**Electronic Monitoring:** GPS Technology allows the Court to track youth in real time with these devices, and 3 units are owned by the Court. Exclusionary zones may be created for protection of crime victim purposes and staff can check on attendance at required meetings. In addition, 16 traditional electronic monitors are owned by the Court for monitoring through a traditional telephone system.

**Drug Testing:** Portable units for instant alcohol testing, instant device drug testing, and laboratory services are for youth, adults, and other cases monitored by the Court.

### FAMILY LAW SERVICES- By The Numbers

Coshocton County Individuals with limited income are able to meet with an attorney to discuss custody, domestic violence, visitation, how to complete forms, discuss procedure and other questions. Clinics are free and scheduled monthly to serve a maximum of 16 clients per session.

#### COURT SECURITY STATION:

- **14, 806** individuals were screened through security in 2019
- Maintains Log Sheets and monitors the Court's Holding Cell to ensure compliance with state and federal standards
- Directs all incoming traffic to proper areas of the building
- Monitors camera systems and other security related items

#### PROBATE GUARDIANSHIP CASES:

- Guardians in Coshocton County are not exempt from State Training Requirements. The Court has hosted trainings to eliminate travel, provides training on flash drives, and directs individuals to free online training.
- With approximately 197 open cases at year end, only 6 Guardians in 2019 had not yet fulfilled training requirements.
