## TAB 1: Complaint for Parentage, Allocation of Parental Rights, Responsibilities and Parenting Time

You are a parent and you want to establish paternity and/or parenting time and/or custody (if no custody order exists)

#### TAB 2: Complaint to Rescind Acknowledgement of Paternity

You want to rescind an acknowledgement that was final <u>LESS</u> than one year ago.

## TAB 3: Complaint for Relief from Acknowledgement or Paternity Determination

You want to rescind an acknowledgement that was final **MORE** than one year ago.

# TAB 4: Complaint for Parentage, Allocation of Parental Rights, Responsibilities and Parenting Time

- You are a parent and no custody order exists, other party does not agree
- You are a parent and you want to establish parenting time, other party does not agree

## TAB 5: Complaint for Parentage, Allocation of Parental Rights, Responsibilities and Parenting Time and Establishment of Shared Parenting Plan

No prior custody order exists, parties agree to establish shared parenting plan

# TAB 6: Complaint for Parentage, Allocation of Parental Rights, Responsibilities and Parenting Time with Parenting Plan

No prior custody order exists, parties agree to custody designation and parenting time

## TAB 7: Motion for Change of Parental Rights, Responsibilities and Parenting Time

You are a parent and you want to change an existing custody order, parties do not agree

#### TAB 8: Motion to Change Parenting Time

You are a parent and you want to change the existing parenting time order only, parties do not agree

#### TAB 9: Agreed Motion for Modification of Prior Court Orders

- All parties agree to a change in custody
- > All parties agree to a change in existing shared parenting plan
- > All parties agree to a change in parenting time

# TAB 10: Agreed Motion for Modification of Prior Court Orders and Establish Shared Parenting Plan

All parties agree to change existing custody orders to a shared parenting plan

#### TAB 11: Verified Motion for Ex Parte Emergency Orders

> May be filed in addition to TABS 1, 4, 7, 8, or TAB 12 in Non-Parent Forms

## **NON-PARENT FORMS**

## TAB 12: Motion to Intervene and Request for Custody or Companionship Time or Visitation

You are not a parent, you want either custody or visitation and there are existing custody orders, parties do not agree (May be filed in addition to Tab 11 in Parent Forms)

## TAB 13: Complaint for Custody

You are not a parent and no custody order exists, other party does not agree

## TAB 14: Complaint to Establish Companionship Time or Visitation

You are not a parent and you want to establish visitation

#### TAB 15: Motion to Change Parenting (Companionship or Visitation) Time

You are a non-parent, you have court ordered visitation that you want to change, parties do not agree

#### TAB 16: Agreed Motion for Modification of Prior Court Orders

- All parties agree to a change in custody (parent or non-parent)
- > All parties agree to a change in visitation (parent or non-parent)

#### **CHILD SUPPORT**

# TAB 17: Motion for Change of Child Support, Medical Support, Tax Exemption, or Other Child-Related Expenses

- Default motion and packet for all child support-related modifications
- Establishment of child support, if not included in original custody actions above, should be referred to CSEA

#### **CONTEMPT**

## TAB 18: Motion for Contempt and Affidavit

Party subject to court order wants to enforce parenting time, payment of medical expenses, and other court orders

## **MISCELLANEOUS**

#### TAB 19: Notice of Intent to Relocate

You want to move from the address you had when custody was granted or last modified

## TAB 20: Grandparent Power of Attorney (No filing fee)

- You want to temporarily allow grandparent to care and make decisions for your child(ren)
- You are also required to file TAB 28 Parent Proceeding Affidavit with this filing

#### TAB 21: Motion to Continue

You want to change a scheduled hearing date to a date in the future

#### TAB 22: Notice of Dismissal

You want to dismiss a complaint or motion you filed

## TAB 23: Request and Affidavit for Service by Publication or Posting

You have attempted to serve another party, but cannot find them

#### TAB 24: Precipe for Subpeona

You wish to invoke the power of the Court to order a witness to appear at a hearing

## TAB 25: Motion for Remote Appearance

You have been ordered to appear for a hearing in person, and request to participate by remote appearance

## TAB 26: Name Change (Adult Packet)

You wish to file a separate Probate Court action to change your name

## TAB 27: Name Change (Minor Packet)

You wish to file a separate Probate Court Action to change the name of a minor child in your custody

## TAB 28: Parent Proceeding Affidavit

You are filing a Petition or Motion regarding the allocation of parental rights and responsibilities, parenting time, custody, or visitation
