Programs that I hope to accomplish in the first few months are an "Adopt-A-Road" program for County and Township Roads and a shredder program for information-sensitive papers that may include credit card info, social security numbers and the like. I am also interested in meeting with local schools to find ways we can work together to provide recycling availability for paper, plastic bottles, cans and other items county schools may be otherwise sending to landfills.

- Bakersville (59469 CR 2, next to the Township Garage)
- Canal Lewisville (Rivercrest Drive- old fire station site)
- Conesville (508 Franklin Avenue)
- Fresno (near Township Garage off Township Road 1045)
- Nellie (2nd Street, next to the Community Center)
- New Guilford (32531 SR 541, Perry Township)
- Plainfield (Main Street/ Park Avenue)
- Warsaw (River View Community Park)
- Tiverton (SR 206/ CR 20, Tiverton Township)
- Tuscarawas Township (Cedar Street)
- West Carlisle (Pike Township Hall)
- West Lafayette (117 Main Street)

Drop-off sites accept:

- Newspaper: office paper, magazines, catalogues and brown paper bags
- Cardboard: Cardboard and paperboard products. Please flatten all containers
- Steel cans: Please rinse, no need to remove labels
- Aluminum cans: Please rinse
- Plastic bottles #1-#7 – no plastic bags, Styrofoam or clamshells

Battery Recycling Program is Returning

Back by popular demand, disposable battery and cell phone drop-off sites will be coming back to Coshocton County in 2018. Boxes will be available after the first of the year, in the mean-time, start collecting your used batteries.

For 9-volt and higher charge batteries, including lithium and cadmium batteries along with cell phones, residents are asked to place the batteries in a plastic bag in order to prevent the possibility of charges meeting and causing heat or fire.
