Thomas Smith Variance

Tiffany presented the Variance request for the Thomas Smith property located in New Castle Township on CR 368 and SR 206. Mr. Thomas is proposing a 10.0 acre split for his son Eric to build a home on. This will leave a remaining acreage of approximately 47.5 acres. There is an existing 16' easement that the Smith's built a driveway this past fall through the permitting process with ODOT off of SR 206. This is the most beneficial access as the current access on CR 368 is in the Floodplain and inaccessible when flooded. The hillside on CR 368 extend the drive that way would be extremely difficult due to the topography, then not accessible during high water. The variance approval would be to allow a subdivision of 10.0 acres with the use of the existing 16' easement for access.

Mr. Hall made a motion, seconded by Mr. Lee to approve the Thomas Smith Variance Request as presented. Mr. Don Wells called for a roll call vote. All vote yea. The motion carried.

Cottonwood Cove Private Road Subdivision

Tiffany presented the Cottonwood Cove Private Road Subdivision. This is located on the Walter Bates property in Linton Township off of TR 118. This is a two lot Private Road Subdivision. Lot 1 is 10.0 acres and the remaining Lot 2 is 68.9 acres. Ms. Rachel Stroup would like to build a home on Lot1. The reviewing agencies have submitted their reports. Surveyor Hitchens and Associates is extending the Private Road into Lot 1 to ensure that the Width to Depth regulations are met.

Mr. Hall made a motion, seconded my Mr. Border to approve the Cottonwood Cove Private Road Subdivision as presented. Mr. Don Wells called for a roll call vote. All vote yea. The motion carried.
