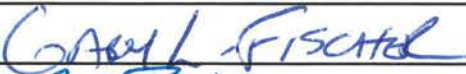
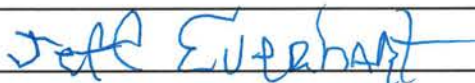

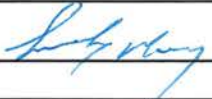
Having no other business, Jesse Fischer moved and Brian Albertson seconded to adjourn and President Don Wells did so at 7:40 p.m.
