We encourage you to order early because there are a set number of seedlings available for the sale. Toward the end of the sale, popular varieties tend to sell out. All orders are filled on a first-come, first-served basis. The deadline for turning in paper order forms is **Friday, March 8**. Online orders can be submitted through **Friday, March 22**, but the available varieties will be quite limited by then. Coshocton Receives District of the Year Award

At the Ohio Federation of Soil & Water Conservation District's Annual Partnership Meeting in Columbus, the Coshocton SWCD was recognized as the 2024 District of the Year. The District's education projects were highlighted, and it was noted that Coshocton does not have an educator on staff but the whole staff works together on District's educational programs. The District was honored to receive the award and looks forward to the education program events coming up this year.



Inflation Reduction Act Provides Opportunities for Coshocton Producers



The Inflation Reduction Act (IRA) passed in 2022 has injected a large amount of funds into existing NRCS cost share programs like EQIP and CSP. Ohio NRCS has been granted 30 million dollars statewide for 2024. IRA funds can help you accomplish your conservation goals, and can be spent on cropland, pasture, and forestry practices. Practices such as cover crops (\$60.64/ac.), grass waterways (\$4330.92/ac.), pasture and hay planting (\$284.87/ac.), prescribed grazing (\$36.47/ac.), tree and shrub

establishment (\$7.54/ac.), forest stand improvement (\$126.72/ac.), and others are core practices that can be funded (these rates are based on typical Coshocton County scenarios). Along with core practices many other supporting practices can also be eligible depending on the conservation plan. Conservation is not a one size fits all process so the best way you can learn if there are IRA opportunities available to accomplish your conservation goals is to contact Mathew Hursey or Josh Britton at the USDA Service Center in Coshocton and schedule a site visit to discuss your goals for your property.

Coshocton SWCD Board Meetings

The Coshocton Soil and Water Conservation District's Board of Supervisors meets once a month. 
