- B. Client Concern Tracy explained CPT is serving an elderly male passenger who has Dementia. The client calls all hours of the night and leaves a lot of voicemails, asks why we called him when he initiated the call and sometimes does not know where he is even though he is in his room. The rider lives at the previous L&K motel and runs across the street to Goodwill when we drop off passengers thinking the shuttle is for him. He has stated that he is used to going without food on the weekends. Tracy has contacted the AAA9, Senior Center (who is also concerned), Anne Randles at Adult Protective Services and requested to well-being checks with CSD and EMS. Because he is oriented to time and place there is nothing they can do. Board members suggested a well-being check be requested when he is at another facility other than his room. Tracy will follow-up with Anne Randles.
- C. CR 621 Multi-use Path Project The project cost has almost double since the original cost estimate from 2022. The County Engineer's office notified ODOT of the cost increase and was allocated and additional \$883,000 which requires and additional \$144,355.97 in local match. Tracy submitted an unrestricted grant application to the Coshocton Foundation asking for assistance with the requirement match. Other possible sources could be Walmart and businesses in the project area.
- D. Carts Twenty CPT riders are currently benefiting from the shopping carts that were made possible by the Coshocton Foundation. Tracy said is was great seeing individuals walking down the streets with the carts and it is making shopping easier for CPT riders and drivers. We have thirty carts left and will run an ad in the Beacon and post flyers in the shuttles.

## V. Mobility Ohio

A. Valerie explained to the group what Mobility Ohio is and handed out an outline of what the project looks like moving forward as well as CPT's role in it.
