Discussion - Identity Theft

Ms. Debbie Howard and Mr. Pat O'Bryan, Pre-paid Legal Services, attended the meeting to share with the Commissioners what they have to offer for the county on Identity Theft. Ms. Howard stated that the FCC recommends that the county offers employees access to legal council in reference to identity theft. They have a policy in place that they will allow the county to utilize for free. They will mitigate any claims to minimize the loss for the county and the employee. She explained the difference between financial fraud which is through credit cards and identity theft which is what the employee can be held responsible for under US law. The cost to the employee for this program is \$12.95 per month to \$34.90 per month. The average is \$11.96 per pay. Mr. Shryock asked what percentage of employees normally enroll in the program. She stated that normally 45 to 50%. The Commissioners thanked them for attending.
