Public Hearing – Vacation – Alleyways/Streets, West Carlisle, Pike Township

At 9:00 a.m. the public hearing for the vacation of Pike Township, Streets/Alleyways in West Carlisle. Mr. Stahl stated that he has a problem with the vacation petition because it will land lock some property. He stated that he had hoped the Trustees would contact us and withdrawal the petition. Mr. Shryock and Mr. Fischer are in agreement with Mr. Stahl. Mr. Stahl then made a motion, seconded by Mr. Shryock to deny the petition of the Pike Township Trustees for the vacation of all of a north-south 16.5 foot alley located along the east line of Lots 21, 28, 58, 51,7 4, 111, 110 and 107; all of east alley, 16.5 feet wide, along the north line of lots 29,28,27,26,and 25; all of a 60 foot wide street located along the south line of lots 33, 58 57, 56 and 55; all of a 16.5 foot wide alley located along the south line of lots 75 and 74; and all of a 16.5 food wide alley located along the south line of lots 108 and 107. Mr. Shryock also stated that he would like it to be known that the Trustees have not had a meeting yet this month so they were not able to act on this petition.
