#### Discussion - EMS Insurance Bonus

Mr. Todd Shroyer, Assistant Director of the EMS, attended the meeting to discuss the issue of giving EMS employees an Insurance Bonus for this year. Mr. Shroyer is concerned that this may cause an issue with other county employees. Ms. Beck stated that the Commissioners past policy has been that since the funds are non-general, it is the determination of the appointing authority to decide how they will give the bonus. Mr. Stahl stated that these employees were brought on under a special circumstance and this is a one time thing. He feels the Commissioners should allow this. Mr. Fischer is in agreement. Mr. Shroyer stated that he did budget for this when they came on to the county and it does save the EMS approximately \$10,000 per month and they would like to give the employees the bonus. The Commissioners stated that they have no problem with him doing this.

### Hopewell/Transportation Contract

Ms. Deb Laney attended the meeting and requested that the Commissioners sign a one year contract between MRDD and Coordinated Transportation to supply transportation for the Board of MRDD and to use the MRDD Shuttles for county transportation purposes. Ms. Laney stated that she feels this will be a win/win situation for everyone and assured the Commissioners that the contract is in the best interest of both parties. Ms. Laney also stated that Ms. Kendall addressed all the issues that she had. She will be able to utilize the MRDD shuttles for coordinated transportation for county residents.

Mr. Stahl made a motion, seconded by Mr. Shryock to sign a one year contract effective August 22, 2008 between Coshocton County Board of MRDD and Coshocton County Coordinated Transportation to supply transportation services for MRDD and to use the MRDD shuttles for county transportation services.
