Discussion - EMS

Mr. Bernie Minet attended the meeting to discuss some EMS issues. He stated that we received a letter form Swiss Valley Ambulance Service. This letter stated that they have a resolution in place that states if they come into Coshocton County on a response, they will be paid \$175.00 for their response. Mr. Minet stated that we sent them a letter stating that we would only pay \$75.00 for their response. They have taken exception to us only paying \$75.00. Mr. Minet stated that their has never been a contract signed with Swiss Valley. He wanted to update the Commissioners and let them know where he is on this issue. Mr. Fischer stated that he thought we worked this out in 2007. Mr. Minet stated that another problem is that we have no response with Swiss Valley either and it is very difficult to communicate with them. We have that capability, but they will not monitor us or their antennae towers don't match-up with ours. Mr. Fischer stated that he discussed this with Mr. Curtis Garber, Crawford Township Trustee to help alleviate this problem. He will meet with Crawford Township Trustees and will go forward from there. The Commissioners asked Ms. Pat Harsh and Ms. Tiffany Swigert to attend the meeting to discuss the ambulance service accident. Mr. Fischer asked how the price for the ambulance was determined. Ms. Harsh stated that it is not based on replacement value but on the value that it has today. Ms. Swigert stated that with private insurances, you can negotiate that price. Mr. Minet stated that the vehicle is beyond repair. He also stated that the replacement cost could be around \$140,000.00. Mr. Minet stated that he will look at State Purchasing to determine if he can get a better price. Mr. Fischer asked Ms. Harsh to get estimates for the salvage of the vehicle. Mr. Minet then stated that he would like to write a resolution or policy stating how ambulance transports are paid. He presented the Commissioners with a letter suggesting how we go about doing this. He would like them to review the letter or resolution and get back with him. The Commissioners thanked him for attending and will get back with him as soon as possible.

Bid Opening - Dining Room Set
