2008 Juvenile Court Cases

Received the Juvenile Court Cases report for 2008 from Juvenile Judge C. Fenning Pierce.

Investment Portfolio

Received the Investment Portfolio for the 2008 calendar year from Mrs. Michelle Darner, Coshocton County Treasurer. Mrs. Darner stated that she feels we ended the year on a good note. We earned \$495,000 in investment income for 2008. The interest rate fell dramatically from the beginning of the year to the end. It went from 3% to almost .77%. Approximately half of our portfolio will be available for re-investment in 2009. Our investable balance continues to drop as our revenue decreases. We have an average of 3% on our investments for 2009. The Commissioners thanked her for attending.

Discussion - Bulk Water Rate with the City

Mr. Charles Hathaway attended the meeting to ask where the Commissioners are on the water negotiations. Mr. Fischer stated that we are working with RCAP (Rural Community Assistance Program) on the mediation of this issue. Mr. Hathaway stated that he is to have a meeting today and would like to be able to update on this issue.

2008 IT Department Report

Mr. Mike LaVigne attended the meeting to give an annual update on the IT Department. Mr. LaVigne stated that over the course of one year we have replaced every switch in the county. We purchased the left hand SANS and we have almost completely integrated them. He feels that this was a really good purchase on the part of the county. He stated that we have started the Personnel Data Base, but are having difficulty getting departments to utilize it. They developed a new ticket system for both IT and Maintenance. These are basically work orders that can go to their computers as well as their phones. They created an Inventory Data Base for the Maintenance Department as well. This should help keeping the Maintenance Department updated on what they have available in their department. Keeping the website updated is always a challenge as departments change daily. We continue to see more and more traffic on our website. In 2008 Soil and Water has come on board the county network and server. DJFS and the Park District are now on the SSI System for the Country Auditor. He worked to get this system available to these departments. He stated that One Community will be here on the 22nd of this month to speak with the different groups about the fiber that will be coming to the county. Mr. LaVigne is the point person in this county for this project. He stated that they plan to have interim fiber here for the county by the time our contract is up with AT&T. This will be 3 times more reliable and 10 times faster at no additional cost to the county. The ability to share resources is invaluable. He also stated that he would like to utilize the Hospital as a Disaster Recovery sight as well as being one for them.
