#### Discussion - Lyme Disease Awareness

Ms. Crystal Stull attended the meeting to give a presentation on Lyme Disease. She presented a six minute video on Lyme Disease. Ms. Stull stated that the disease is highly controversial. Her granddaughter does have the disease. She also has Lyme Disease as well as her daughter. She stated that the government made the disease. It was made for warfare. In the past doctor's were punished for treating this disease. Now, they are being criticized for not treating the disease. She presented the Commissioners with documentation and a lab form. The test takes three weeks to get the results. Mr. Lee asked how many cases have been diagnosed in Ohio. She stated that he figures are very inaccurate because families leave the state to be tested. This disease attacks the central nervous system. It is very important that people be on the look-out for this disease. Mr. Shryock asked if the test for the disease is an affirmative test. She stated that the test can show a false positive. It is important to have a doctor that is Lyme literate in order for them to be able to read the test. Mr. Lee asked if she feels her family contracted the illness in Ohio. She stated that it is not just ticks that carry the disease, horse flies, fleas, and mosquitoes also carry the disease. She also stated that any form of insect repellant that contains DEET will work on the repelling of these insects. The Commissioners thanked her for attending.
