Discussion - Adams Township Fiscal Officer

Mrs. Elizabeth McIntire attended the meeting to ask the Commissioners a couple questions. She stated that they had a meeting last night and they have a couple roads that are in really bad shape and she was wondering if there are any grants that she could apply for to help with the repair of these roads. Mr. Shryock stated that if the residents on the road are Low to Moderate income, then they might be able to apply for CDBG Grant funding. However, that grant is already closed for the 2009 year. Mr. Shryock then asked if they have any road levies in the township and she stated that they did. Mr. Lee asked what her tax valuation was for the township. Mrs. McIntire did not know what the valuation was. Mr. Lee stated that he has been a Fiscal Officer for many years and most grants make you show that the improvement will last for at least 10 years. Mrs. McIntire thanked the Commissioners for their information.

Discussion - Matt Robinette

Mr. Matt Robinette attended the meeting at the request of the Commissioners to discuss several issues about the Water and Sewer. Mr. Shryock asked Mr. Robinette to contact Mr. Rousch at RCAP to see how he is progressing with the City Water Agreement. Mr. Shryock then stated that Mr. Robinette also needs to get the information for the Three Rivers Fire District so that we can get it out to bid. It is very vital that this be done because we only have until the end of the year to complete the project. They instructed Matt to have GGC Engineers prepare the general requirements and technical specifications for this project. Matt stated that he will get right on things. The Commissioners thanked him for attending.
