House Bill 124

Mr. Rusty Dreher and Mr. Steve Cox attended the meeting to update the Commissioners on House Bill 124. Mr. Dreher stated that this will create a new enforcement section of the law. At this time, the Dog and Kennel is under the 955 section of the Ohio Revised Code. This new law would create a new section of the law (956) that would create a Kennel Control Authority that would look into the puppy mill issues. The Dog and Kennel Association is concerned that they will be the ones to receive all the phone calls relating to this issue. Mr. Dreher stated that County Commissioners Association of Ohio (CCAO) and the Dog and Kennel Association is not opposing or supporting this law. They plan to watch and see what happens. Mr. Dreher stated that they feel much better after talking to Mr. Cole from CCAO as they were concerned that this law was going to increase their work load, but were informed that this should not be the case. Mr. Cole told Mr. Dreher that he would keep him informed about this issue. The Commissioners thanked them for attending.
