Public Safety Awareness Day

Ms. Janice McFerren, Mid-east Career Center and Ms. Ann Combs, Siegrist Auditorium attended the meeting to explain the Public Safety Awareness Day. They would like to honor our community fire fighters, peace officers and emergency medical services. This will be held for a six county area. They will honor one individual from each entity in each of the six counties. She stated that Danielle Peck will be performing that evening and before she performs, they would like to have one Commissioner to present the award to the recipients within their county. This will occur on October 17, 2009. This will be a day long event with the evening ceremony being the grand-finally. Ms. Combs stated that this will be a ticketed event and the proceeds will go to Mid-east Career Center to help offset the cost of providing these courses. There will be many demonstrations and activities for families. Ms. Combs stated that they are asking that the Commissioners support their efforts in the way of a proclamation, or funding for the event. Mr. Shryock asked what funding amount they are requesting. Ms. McFerren stated that Muskingum County gave \$100 toward the event, but any show of support would be appreciated. Mr. Shryock asked what the ticket prices are. Ms. McFerren stated that they are \$15.00 and they have 1776 seats. Mr. Shryock stated that at least one of the Commissioners will attend the event. Ms. McFerren stated that they hope to continue this event every year. She asked that the Commissioners recommend areas to place the posters in our county and will contact them at a later date for this determination. The Commissioners thanked them for attending.

Sanitary Sewer Discussion

Mr. Steve Lonsinger attended the meeting. Mr. Shryock asked what the intention of the Health Department will be when the Commissioners do a sanitary sewer line project in the county. Mr. Lonsinger stated that if the sewer line is within 200 feet of a home, they are generally required to tap into the line. He stated that once that becomes accessible to the home owner, he will inform them that they are required to tap into the line. Mr. Shryock stated that the Commissioners should
