Janice McFerren-Public Safety Event

Ms. Janice McFerren attended the Commissioners meeting to discuss the public safety event that is to be held in Zanesville on October 17, 2009 @ 7pm. Ms. McFerren asked who from the Commissioners office would be attending. Mr. Fischer stated that he had planned to attend; Mr. Lee and Mr. Shryock also confirmed that they would be in attendance for the ceremony. Ms. McFerren thanked the Commissioners for their time.

Bernie Minet EMS Vehicle Purchase

Mr. Bernie Minet and Mr. Todd Shroyer attended the meeting to discuss the option of purchasing an additional ambulance for 2009. Mr. Shroyer stated that Ford has come out with a new style motor for 2010 and they don't feel they want to try the 2010 model with the new motors when they have 2 new ambulances that are working great from 2009. Mr. Shroyer stated that they could purchase for the same price as they did earlier this year for around \$117,000. Mr. Lee asked what the life expectancy of an ambulance is. Mr. Shroyer stated that they try to get over 200,000 miles on each vehicle. Mr. Fischer asked how many years would 200,000 miles equal. Mr. Minet stated 10 years is the estimated life. Mr. Shryock stated that he feels that Mr. Minet and Mr. Shroyer knows how to run their department and if they feel they need to purchase a new ambulance then they have the green light from the Commissioners to go through the process. Mr. Shroyer stated that they would be using the state purchasing program to purchase the ambulance.

Executive Session-EMS

At 10:15 Mr. Lee made a motion second by Mr. Fischer to go into executive session with Mr. Bernie Minet and Mr. Todd Shroyer to discuss personnel hiring, firing, discipline or compensation. All vote aye. At 10:30 a.m. Mr. Shryock returned the meeting to regular session. There was no action taken.

GGC Engineers-Fresno Sewer Discussion

Mr. Mike Carder from GGC Engineers attended the meeting to give a brief update on the Fresno Sewer Project. The final Permit to install from the EPA should be out this week for the Fresno Force Main to West Lafayette. He hopes to put the Fresno to West Lafayette and the Fresno Collection out to bid by September 14, 2009. Mr. Carder presented an estimate for the archaeological investigation from Weller & Associates, Inc. for an estimated cost of \$11,245.00. Mr. Carder has asked the Commissioners to apply for a Supplemental Design Loan from Ohio Water Development Authority for the Fresno to West Lafayette Force Main to get them through until the stimulus funds come through in late October and then this loan could be paid off with the stimulus dollars. Mr. Carder also presented a draft letter regarding Pearl to Fresno Wastewater System Project Easement Acquisition Plan. Mr. Carder asked how the Commissioners would like to approach the residents. Mr. Shryock stated that he felt it would be best if Mr. Carder or one of his associates could go to each residents home to obtain those signatures.
