Discussion-Video Arraignment Municipal Court

Honorable Tim France, Mr. Chris McCabe from the Municipal Court and Mike LaVigne, IT Director attended the Commissioners meeting to discuss video arraignments. Municipal Court would like to be added to the county's internet so that they can have the ability to have video arraignments. Mr. Shryock stated that the Commissioners would need to install a switch that would cost around \$5,000. Mr. McCabe asked what the purpose of the switch is. Mr. LaVigne stated that the switch was necessary for the Municipal court to connect to the county courthouse. Judge France stated that he would pay the \$5,000 for the switch with special project funds and all other cost incurred for the installation. Mr. LaVigne asked if the City would be coming on as well. If so, he would need to install a larger switch with 48 ports as opposed to a 24 port switch. Mr. McCabe asked what the cost difference would be for the larger port. Mr. LaVigne stated that it would cost approximately \$9,000. Judge France stated that he would like to have the larger switch installed in case the city would decide to join him. He then asked how soon could this happen. Mr. LaVigne stated he could have them up and running within 30 days. Judge France said he would just like to have it installed before the end of the year.


