1st Public Hearing - 2010 CDBG Grant

Mrs. Beck stated that the county anticipates applying for approximately \$105,000.00 in CDBG Formula Funding for 2010. She stated that letters have been sent to all villages as well as townships giving information as to the requirements for applying for these funds. She stated that activities must be designed to primarily benefit low or moderate income persons, or aid in the prevention or elimination of slum and blight, or meet an urgent community need. She then reviewed projects from 2009 and 2008. That being all, Mr. Lee closed the public hearing.
