Municipal Court IT Agreement

Judge Tim France and Mr. Larry Miller attended the meeting to discuss the IT proposal. Judge France asked when we could start. He would like to get things going before April 1st. He also asked how we would bill him. Would it be monthly, quarterly or how will we bill them. The Commissioners stated that they feel that it will be billed monthly in arrears. Mr. Shryock stated that the IT Department can start next week and if there are no problems, Mr. LaVigne feels he can have it done prior to April 1st. That being all, Mr. Fischer made a motion, seconded by Mr. Shryock to go into an agreement with Coshocton Municipal Court to provide IT services by the county at a cost of \$1.90 per day per computer along with a one-time start up fee of approximately \$109.00 per computer. In addition, there is a charge of \$55.00 per hour/per employee to convert the court to the county IT System. This will be billed at 3/5 the total cost of the project.

Discussion – Mr. Charles Lanning

Mr. Charles Lanning attended the meeting and stated that the Humane Society let an employee go that put the animals on the internet for people to adopt. Now, the two employees left out there do not know how to utilize a computer. So, these dogs are not being put on the internet. He feels this is very vital in the adoption of the dogs as well as cutting down on putting the dogs down. He stated that they are trying to keep the adoptions up and feel this will increase unnecessary euthanasia. Mr. Lee stated that the Humane Society does have a contract to run the shelter through the end of this year. Mr. Shryock stated that the Ohio Revised Code only speaks to the Humane Society when running the County Shelter. Therefore, the Commissioners cannot utilize anyone other than themselves or the Humane Society to run the animal shelter. Mr. Lanning stated that he would be willing to help the Commissioners operate the shelter if they were inclined to go in that direction. The Commissioners thanked him for attending.

America in Bloom in Coshocton County

Mrs. Dorothy Skowrunski, Mrs. Kerry Rapp, Director of Clary Gardens and Mr. Bill Freund attended the meeting to introduce America in Bloom to the Commissioners. She stated that next year is the county's Bicentennial. They would like to get as many daffodils as possible to start the Bicentennial. She explained what America in Bloom is. America in Bloom is a not-for-profit motivating organization that serves as a catalyst for building community pride and participation through a focus on plants, gardens and community pride. It is a competition between communities similar in size throughout the nation. The first year we will participate and not compete. She is requesting that the Commissioners give a proclamation of support for this effort. The City of Coshocton will be entered into this project. They would also like to ask the county to participate to create a total beautification of our county for the bicentennial. Ms. Rapp stated that they intend to keep this going for years to come and the judging will be done on June 21st and 22nd. Mr. Freund stated that everywhere he has spoken to people about this project this has been a very positive endeavor for their communities.
