Discussion - Cops Grant

Lt. Jim Crawford and Sheriff Tim Rogers attended the meeting to discuss the possibility of the Commissioners applying for a Cops Grant. Sheriff Rogers stated that they have the opportunity to apply for this funding and they did apply for it last year, but were turned down. They are eligible to apply again this year. They are requesting approximately \$369,370.00. Lt. Crawford stated that this will be for 2 employees for three years. They currently have two positions open in the county and this would fill those positions for three years and then the county would have to pay for the fourth year. Sheriff Rogers stated that this is a big safety factor for those officers working alone in the county. He feels this would be very beneficial to apply for these monies. He understands that there may be an issue with funding in the fourth year. However, he feels it is better to apply for the funding and worry about the fourth year when it comes. Mr. Lee stated that we are aware of the issues and there would be a possible issue with the fourth year and then if we were unable to come up with the funding, we would have a year of unemployment as well. He also asked what they feel their chances are of being granted the funding. Sheriff Roger's stated that he feels their chances will be better this time than they were the last time. Mr. Lee stated that he feels a little uncomfortable with having to fund the 4th year as he is concerned with the county's ability to finance it. Mr. Shryock stated that he is concerned as right now it is difficult to determine if the funding will be in place or not in four years. Mr. Lee then asked what would happen if our funding drops again and we would have to make additional cuts. Sheriff Rogers stated that if that would happen, they would have to lay-off employees, but these grant monies would continue for three years. Lt. Crawford stated that he feels it would be beneficial to apply for the funding rather than not apply. Mr. Shryock stated that he hates not taking advantage of this opportunity. However, he is very concerned that the county will not be any better off in three years. Sheriff Rogers stated that they fully understand that the positions will be funded for three years and they may have to lay-off employees to continue the funding of these positions in the fourth year. The Commissioners stated that as long as they understand and are still willing to take that risk then the Commissioners will approve the Sheriff to apply for this grant. That being said, Mr. Shryock made a motion, seconded by Mr. Fischer granting permission to the Sheriff to apply for the 2010 CHRP's Hiring Recovery Grant Program.
