Jim Crawford/2011 Litter Control Grant Funding

Lt. Jim Crawford attended the meeting to discuss the 2011 Litter Control Grant. Lt. Crawford stated they are ready to submit their 2011 Litter Control grant budget to the CFLP Waste District and would like direction from the Commissioners. He was told by Carol Philips that the program would be flat funded for 2011 and that there was only \$157,500 available for the Litter program. Mr. Shryock stated that the \$157,500 is for optional programs in Coshocton County such as Litter Collection, Health Department and the Litter Control program. These programs received \$166,922 for 2010 and will have \$157,500 available for 2011. Mr. Shryock recommended that sometime in the next couple of weeks that they have a meeting with Mr. Crawford, Mr. Whereley and Mr. Lonsinger to discuss how these funds should be divided.
