Juvenile/Probate Court Building Issues

Mr. Doug Schonauer attended the meeting to discuss some building issues at the Juvenile/Probate Court Building. Mr. Schonauer stated that their camera system is crashing on a regular basis and needs to be replaced. Getting service and support has been a great challenge. He has received a quote from Mr. LaVigne and he is interested in bringing some vendors in to make a quote for us. He feels we can still utilize the cameras, but will need new equipment for everything else. He had hoped to get another year out of this system, but it has become clear that they will be unable to do this. He is asking that he can pursue getting quotes to replace the system. Also, he may need to transfer monies to cover the cost. They have just created a fund this year to help with the cost of the security system at the court. They have approximately \$1,500 in that fund at this time. Mr. Shryock asked if it is possible to put a server in a central location to serve several buildings. Mr. Schonauer stated that yes he believes there is that capability, but is not certain of the cost effectiveness. The Commissioners stated that he should proceed with getting quotes. Mr. Schonauer stated that he also has some issues with the cleanliness of the building. The public areas of the building need to have the walls repainted and they would like to hire a company to come in and paint those walls. They will pay for this from their funds. The Commissioners stated that they have no issue with them doing this. Mr. Schonauer stated that AT&T did some wire work on the building last year and has left several hanging wires. They also have a cable lying on the building awning and he feels it will rot the awning soon. The Commissioners stated that he should contact Mr. Mike LaVigne to get in touch with AT&T to see if they can get someone over here to correct this situation. Mr. Schonauer thanked the Commissioners for their time. The Commissioners thanked Mr. Schonauer for attending.
