Omnicity Update

Mr. Jon Mosier, Mrs. Sue Shipitalo, Mr. Chuck Wiseman and Mr. Bob Meissner attended the meeting. Mr. Meissner stated that the Conesville tower is now up and operational. They are booking installations for that area at this time. The Fresno Relay tower contract for that sight is now complete and installation should begin next Tuesday. They hope to complete the installation two - three weeks later and start booking installations. The County Road 93 site contract has been finalized and the expected installation date is Wednesday October 20th. They will schedule the booking installations shortly thereafter. Mr. Mosier stated that he is scheduled to go onto the MARCS tower at Conesville on October 25th with the Sheriff's equipment. They hope to be able to utilize all three MARCS towers with the Sheriff's equipment. This will fill-in on the dead areas in the county. Mrs. Shipitalo asked about a new pricing structure and Mr. Meissner stated that they completed 12 installs last week. Their goal is 15 per week and he is pushing for that. He stated that the Omnicity Call Center is now answering all Ohio calls. He then stated that they now have an internet satellite available to residents in the Coshocton County area. He stated that the cost for this service to residents will be \$300 install fee with a \$150 rebate that will be given. They normally require residents to sign a two year contract, but they will give the resident an option if fixed wireless becomes an available at a cost of \$50.00. The cost is \$77.50 per month for this service. Mr. Meissener stated that there are some rare instances where they may not be able to hit every single home with the satellite. There are ways to work around these issues though. The Commissioners thanked everyone for attending.
